## **RESTORATION ORDER**

WHEREAS, recognition was granted to the institution, namely to Shri Siddhi Vinayak College 427, Colony, Morar, Gwalior-474006, Madhya Pradesh under section 14 (3) A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) and Conducting D.El.Ed & B.ED Course (50 Intake) vide order No. WRC/5-6/90<sup>th</sup>/2006 dt. 30.10.2006 & vide order no. WRC/2-32/223295/76/2005/6235 dt. 09.08.2005.

AND WHEREAS, Revised Recognition order was issued to the SHRI SIDDHI VINAYAK COLLEGE, 427, COLONY, MORAR, GWALIOR-474006, MADHYA PRADESH for conducting B.Ed programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16. Vide Order No. WRC/APW01684/223295/2015/145978 dt. 31.05.2015.

Now, Therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993 and in accordance with Regulations, 2014, the Western Regional Committee, NCTE hereby grants permission to Shri Siddhi Vinayak College, Run By Shri Kanha Shiksha Prachar Prasar Evam Samaj Kalyan no./Village-Khureri, 1503/1, 1505/2, Street Plot/Khasra no. tehsil/Taluka/Town/City/District-Gwalior, Madhya Pradesh-474006 for conducting D.El.Ed. (Increase in intake) programme of 2 (Two) years duration with an annual intake of 50 (fifty) students (one additional unit) thereby totaling to 50+50=100 (one hundred) students from the academic session 2017-WRC/NCTE/APP3122/222131/254th/D.El.Ed. (Increase order no. intake)/{M.P}/2016/168589 dt. 20.06.16.

AND WHEREAS, The matter was considered by the WRC 301<sup>st</sup> meeting held on 17<sup>th</sup> to 18<sup>th</sup> January 2019 and the Committee decided as under:

The institution is required to submit an affidavit stating all the courses with intake run by the institution on the existing premises with supporting land documents (certified), current staff list duly approved by the affiliating body in original and bank statements regarding payment of salary to the faculty members.

Hence, Show Cause Notice be issued to the institution u/s 17 of the NCTE Act, 1993. Reply should be submitted within one month, failing which recognition will be withdrawn."

Accordingly, Show cause notice was issued to the institution on 07.02.2019.

Accordingly, The reply of show cause notice was not submitted by the institution.

AND WHEREAS, The matter was considered by the WRC 306<sup>th</sup> meeting held on 29<sup>th</sup> to 30<sup>th</sup> April 2019 and the Committee decided as under:

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

- The Show Cause Notice was issued to the institution on 07/02/2019.
- The institution has neither submitted reply nor submitted the documents asked in the Show Cause Notice dated 07/02/2019.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 on the grounds mentioned below-for D.Ed. (D.El.Ed.) programme with effect from the end of the academic session next following the date of communication of the said order."

The institution has not submitted the reply of show cause notice issued on 07.02 2019 for D.El.Ed Course was withdrawn vide order dated 10/05/2019 and B.Ed course was withdrawn vide letter dated 01.08.2019 (  $309^{th}$  WRC meeting held on 23-26 July 2019)

Accordingly, Withdraw Order issued to the institution on 10.05.2019.

AND WHEREAS, the institution was filed an appeal, and the authority remanded back the case to WRC for re-consideration.

During the process of granting recognition to the institution for D.El.Ed and B.Ed course, the institution file a W.P. vide No. 8159/2021 dated 1-.08.2021 and No. 1709/2022 dated 28.01.2022 to seek immediate relief.

AND WHEREAS, The matter was considered by the WRC 364<sup>th</sup> meeting held on 15<sup>th</sup> to 17<sup>th</sup> June, 2022. And the Committee decided as under:

The original file of the Institution along-with other related documents were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The institution has submitted all the required essential documents as required under NCTE Regulations 2014

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the Institution for B.Ed and D.El.Ed. Course be restored as under:-
