**RESTORATION ORDER**

WHEREAS, recognition was granted to the institution, namely to **SHIVAM COLLEGE-3, LAL BARRA ROAD, WARD NO. 11. KATANGI, BALAGHAT, MADHYA PRADESH** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. APW05520/223597/WRC/5-6/112/2008/49141-43 dated 29.12.2008.

2. **AND WHEREAS**, Revised Recognition order was issued to **SHIVAM COLLEGE, LAL BARRA ROAD, WARD NO. 11. KATANGI, BALAGHAT, MADHYA PRADESH**, vide order No. WRC/APW05520/223597/112/2015/137416-26 dated 27.05.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic units of (50 students each) from the academic session 2015-2016.

3. **AND WHEREAS**, Compliance was not Submitted as per regulations 2014.

4. **AND WHEREAS**, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. **AND WHEREAS**, a Show Cause notice was issued to the institution on 29.05.2017 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order:

6. **AND WHEREAS**, the reply of show cause notice was submitted by the institution on 10.10.2017.

7. **AND WHEREAS**, the matter was placed in 310<sup>th</sup> Meeting held on August, 19-21 2019 of WRC and the Committee decided that. "The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"The Show Cause Notice was issued to the institution vide letter dated 29/05/2017. The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

8. **AND WHEREAS**, the Withdrawal order was issued to the institution on 05.09.2019.

9. **AND WHEREAS**, the institution filed an Appeal to the Council on 03.11.2019 and the Council vide its order dt. 13.10.2020 remanded back the case to the WRC, NCTE for necessary action and accordingly the institute submitted related documents in WRO vide letter dt 04.11.2020.

10. **AND WHEREAS**, the matter was placed in 329<sup>th</sup> Meeting held on 17-19<sup>th</sup> February 2021, of WRC and the Committee decided "The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that that and noted the following:-

1. The institution is required to submit latest Staff list duly approved by the Registrar of the concerned affiliating body clearly indicating the seal and signature of the Registrar along with faculty approval letter issued by the concerned affiliating body.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 14 of the NCTE Act for B.Ed programme.

11. **AND WHEREAS**, the Final Show Cause Notice was issued to the institution on 11.03.2021, and its reply received on 15.06.2021.

12. **AND WHEREAS**, the matter was placed in 339<sup>th</sup> Meeting held on 28-30 July 2021 of WRC and the Committee decided that.

*"This is a RPRO case and same was remanded back by the Appellate Authority.*

***The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the Institution for B.Ed course with an annual intake of 100 students (Two units) be restored."***

13. NOW THEREFORE, recognition dated 29.12.2008 and revised recognition order dt. 27.05.2015 issued to the institution viz **SHIVAM COLLEGE, LAL BARRA ROAD, WARD NO. 11. KATANGI, BALAGHAT, MADHYA PRADESH** for B.Ed. course is hereby restored permitting the total annual intake of 100 (two units of 50 students).
