ORDER

WHEREAS, the institution, namely, JANSEVA SHIKSHAN MANDALS, DIST.THANE, MAHARASHTRA was granted recognition by WRC, NCTE for B.Ed. course of one year duration for an annual intake 60 seats from the academic session 2000-2001 vide order No.WRC/5-6/22/2000/7138-43 dated 03.10.2000.

2. **AND WHEREAS**, order for revision/re-fixation in intake was issued to the institution viz.Janseva Shikshan Mandals, College of Education At. Gandhi Camp Shivale, Tal. Murbad, Thane-421401, Maharashtra vide order dated 11.04.2005 enhancing the intake of B.Ed. course from 60 to 100 seats.

3. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, revised recognition order was issued to the institution vide order No.WRC/APW0417/113023/APW01919/113023/2015/146037, 050, 054, 055, 060, 062, 064 dated 31.05.2015 for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016.

4. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice was issued to the institution dated 09.12.2016.

5. **AND WHEREAS**, the institution vide letter dated 11.01.2020 has submitted an application for grant of permission for reduction of intake in B.Ed. course from 100 seats to 50 seats enclosing therewith a copy of resolution of the society.

6. **AND WHEREAS**, the matter was considered by WRC in its 378th meeting held on December 21-22, 2022 and the Committee has decided the following:-

"The original file of the Institution along with other related documents were carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Initial recognition was granted for B.Ed. course of one year dated 03.10.2000, 11.04.2005.
- Revised order was issued for B.Ed. course of two years dated 31.05.2015.
- Show cause notice dated 09.12.2016 was issued due to non-compliance of conditions as required under NCTE Regulations, 2014.
- The proposal submitted by the institution vide letter dated 11.01.2020 for reduction of B.Ed. intake from 100 (two units) to 50 (one basic unit).

In view of the above, the Committee decided as under:

The institution be allowed permission for the reduction of B.Ed. intake from 100 (two units) to 50 (one basic unit) w.e.f. the commencement of the academic session 2022-2023. The Affiliating Body/State Government and others be intimated accordingly.

Further, the Committee decided as under:

Show Cause Notice be issued u/s 17 for compliance of conditions of Revised Recognition Order by the institution accompanied by an original affidavit within 30 days from the date of uploading of minutes on the website failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations."

7. **NOW THEREFORE**, permission is hereby granted to institution viz. **JANSEVA SHIKSHAN MANDALS, COLLEGE OF EDUCATION, AT POST-GANDHI, CAMP SHIVALE, TAL. MURBAD, DIST. THANE MAHARASHTRA** reducing the annual intake of B.Ed. course from 100 students (two units of 50 students each) to 50 students (one unit of 50 students) w.e.f. the commencement of the academic session 2022-2023.
