**RESTORATION ORDER**

Whereas, recognition was granted to the institution, namely, 2014 Naran Lal Institute of Teacher Education, Run by Shri Mohanlal Harkishandas Kansara, Kelavani Trust near Railway Station, Naranlala compound, Navsari, Gujrat-396445 under section 14 of NCTE Act, 1993 for conducting B.Ed. course with an annual intake of 100 students vide order no. WRC/5-6/39/2002/05735-39 dt. 20.09.2002.

2. And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the 2014 Naran Lal Institute of Teacher Education, Run by Shri Mohanlal Harkishandas Kansara, Kelavani Trust near Railway Station, Naranlala compound, Navsari, Gujrat-396445 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

3. And whereas, after the receipt of affidavit dt. 13.01.2015 from the institution, a revised recognition order no. WRC/323024/2015/139604 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from session 2015-16.

4. And Whereas, the matter was placed before the WRC in its 255<sup>th</sup> Meeting held on June 22-24, 2016 and the Committee decided to issue show cause notice dt. 05.08.2016 to the institution.

5. And Whereas, reply dt. 26.08.2016 of institution was placed before the WRC in its 277<sup>th</sup> meeting held on 29<sup>th</sup> - 30<sup>th</sup> June, 2017 and Committee decided as follows:-

"The case file was seen. In response to the WRC letter dt. 05/08/2016, regarding fulfillment of requirements for 2 units of the B.Ed. course, the institution has represented that it had requested only for 1 unit (50 students). Keeping this in mind the WRC looked at the staff profile and found that the institution had submitted a list of 1 Principal and 6 faculty members. Out of these, the faculty members at serial no. 6 and 7 cannot be considered because their appointments are on contractual basis.

Further, there is a shortage of 1 faculty member (requirement is 1+7).

For this existing unit to function, the institution is required to appoint 3 faculty members on regular basis. Of these, 1 should be from Physical Education and another from Performing Arts or Fine Arts. The third can be Methodology/Foundation course. The institution should submit the full list of faculty duly approved by the affiliating body for considering the continuation of Recognition for 1 unit of B.Ed. from the session 2017-2018.

As per NCTE Regulations, 2014, FDRs for 12 lakhs in joint operation with the RD, WRC is required. The institution should also fulfill this condition.


**Show Cause Notice be issued on the above grounds and reply should be received within 1 month."**

6. And Whereas, show cause notice No. WRC/323024/B.Ed./Guj./2017/187216-217 dt. 05.07.2017 was issued to the institution.

7. And Whereas, reply dt. 20.07.2017 of institution was placed before the WRC in its 282<sup>nd</sup> meeting held on October 24<sup>th</sup> - 26<sup>th</sup>, 2017 and Committee decided as follows:-

"The case file was seen. Show Cause Notice dated 05.07.2017 was issued to the institution. The institution vide its reply dated 20.07.2017 has submitted a list of one Principal and 6 staff members duly approved by the Registrar. While lecturer at S.No.8 is not approved. Further, lecturers at S.No.5, 6, 7, 8 are not appointed on regular basis.

The institution has not submitted additional FDR for Rs.4.00 lakhs as was indicated in the Show Cause Notice.

The institution has not complied to the requirements of the Show Cause Notice.

**Hence, Recognition is withdrawn from the session 2018-2019."**

8. And Whereas, a withdrawal order no. WRC/323024/GUJ./282<sup>nd</sup>/2017/192467-474 dt. 02.11.2017 was issued to the institution.

9. And Whereas, the institution had filed an appeal at NCTE Hqrs. New Delhi and the Appellant Authority vide order dt. 12.07.2018 has decided as follows:-

*"After Perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing the Committee concluded that the matter deserved to be remanded to WRC with a direction to consider these documents to be submitted to them by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the WRC the documents relating to faculty approval and FDRs submitted in appeal with their letter dt. 23.05.2018 within 15 days of receipt of the orders on the appeal. In the meanwhile, the order of withdrawal shall be kept in abeyance.*

*The Council hereby remands back the case of Naran Lala Institute of Teacher Education, Navsari, Eru Char rasta, Navsari, Gujarat to the WRC, NCTE, for necessary action as indicated above."*

10. And Whereas, reply dt. 23.07.2018 of institution was placed before the WRC in its 295<sup>th</sup> meeting held on July 30<sup>th</sup> - 31<sup>st</sup>, 2018 and Committee decided as follows:-

*"The case file was seen. This is a case of appeal. The Appellate Authority vide order dated 12.07.2018 has remanded the case to WRC for further processing the application.*

*The WRC examined the file and found that the institute has now submitted a staff profile of 1 Principal and 7 faculty members who are approved by the competent authority. However, it is seen that staff members at sr. 7 & 8 do not have the NET qualification as per NCTE notification published on 09.06.2017.*

**Hence, compliance should be submitted within one month failing which the withdrawal orders dt. 02.11.2017 will stand."**

11. And Whereas, Conveyed letter No. WRC/323024/B.Ed./295<sup>th</sup>/Guj./2018/199542-545 dt. 17.08.2018 was issued to the institution.

12. And Whereas, reply dt. 27.08.2018, 28.12.2018 & 12.03.2019 of institution was placed before the WRC in its 308<sup>th</sup> meeting held on June 19<sup>th</sup>-21<sup>st</sup>, 2019 and Committee decided as follows:-

*"In view of the Hon'ble High Court order dated 26/03/2019 in SCA No. 5972 of 2019. As per the direction of the Hon'ble Court, the committee considered the reply of the institution dated 22/09/2018 and found in order as per NCTE Regulations 2014.*

**Hence, the committee decided to restore the recognition for B.Ed. course for one unit ( 50 students)."**

13. Now Therefore, the recognition granted to the institution for conducting B.Ed. course has been restored as per decision of the WRC in its 308<sup>th</sup> meeting and Institution is permitted to continue the existing B.Ed. Course of two years duration with an annual intake of 50 seats (one basic unit of 50 students).



14. It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.

**Revised order no WRC/323024/2015/139604 dt. 31.05.2015 be treated as cancelled from the date of issue of this order.**
