Sub: Implementation and enforcement of the revised norms and standards for various teacher education programmes – requirement of core teaching staff having requisite professional and academic qualifications.

(Institutional Code - 312028)

Sir/Madam,

The National Council for Teacher Education (NCTE) has since issued the National Council for Teacher Education (Norms and Standards for Recognition of Teacher Education Programmes) Regulations, 2001, notifying the revised Norms and Standards for various Teacher Education Programmes. These Regulation were published in Part III, Section 4 of the Gazette of India (Extra Ordinary) on September 4, 2001

In the norms and standards notified by the NCTE, professional and academic 2. qualifications required of the core teaching staff has been prescribed for various teacher education programmes. Apart from the professional and academic qualifications prescribed by NCTE, for teacher education programmes leading to a University degree like B.Ed., M.I.d., B.P.Ed. and M.P.Ed., the faculty members are required to have such other qualifications as may be prescribed by other regulatory bodies like the University Grants Commission (UGC) Since it is beyond the purview of NCTE to enforce requirements of other regulatory bodies, the concerned affiliating University may ensure enforcement of such requirements as may be prescribed by it and / or other statutory bodies such as UGC etc. through mechanisms such as notification of the posts by the institutions in newspapers having State wide circulation and association of a nominee of the University in the Selection Committee etc. The matter was further considered by the council at its meeting held on 20.05.2002. It was felt that the Council has no mechanism to verify the authenticity of the list of teachers submitted by the application The Council resolved that list of teachers submitted by the application institution should have been approved by the concerned university in the case of degree level teacher education programmes and by the SCERT/Directorate of Elementary

Education or the concerned Directorate in the case of diploma level teacher education programmes. Accordingly, it is requested that necessary approval to the list of teachers submitted by the applicant institution may be accorded by the concerned university in the case of degree level courses and by the concerned Directorate in the case of diploma level programmes; needles to say, in absence of such an approval, it may not be possible to consider grant of recognition to the institution.

- 3. In regard to other academic staff for teaching physical education, art, work experience, information technology literacy etc. the qualification shall be as prescribed by the concerned State Govt. The State Govts./Universities are accordingly requested to ensure that such teachers have the necessary qualification prescribed by the State Govt.
- 4. In regard to the terms and conditions of teaching staff, administrative staff and other staff, the institutions are required to follow the policy of the State Govt./affiliating University.
- 5. In pursuance to complement the above, It is requested to submit the staff list for duly countersigned by concerned university/SCERT/Concerned Directorate by 31st December 2002 at the latest countersigned. Subsequently the list is to be submitted with the performance appraisal report every year.
