RESTORATION ORDER

WHEREAS, the institution, namely, LATE DAGADABAI CHAMPALALJI BIYANI SHAIKSHANIK VIKAS, BHUSAWAL SANCHALIT BIYANI B.ED. COLLEGE, AT. MIRGAVHAN, NEAR GOVT. ITI, JAMNER ROAD, BHUSAWAL, JALGAON-425201, MAHARASHTRA was granted recognition by WRC NCTE for B.Ed.(ENGLISH) Course with an annual intake of 100 students vide order No.WRC/5-6/Appeal/2008/36941-36946 dated 01.07.2008.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No.WRC/APW02728/123324/2015/151930-151937 dated **27.08.2015** for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 100 students each) from the academic session 2015-16.

3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on 05.12.2016.

4. AND WHEREAS, the reply submitted by the institution vide letter dated 20.12.2016.

5. AND WHEREAS, the matter was considered by the WRC in its 316th meeting held on August 27-28 & September 4, 2020 and the Committee decided as under:-

"The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institution have not yet shifted they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act days to all such institution which have been permitted or rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises earliest and placed before WRC for consideration and decision".

6. AND WHEREAS, show cause notice was issued to the institution on 09.10.2020. In response, the institution has not submitted any reply.

7. AND WHEREAS, the matter was considered by the WRC in its 321st meeting held on November 09-11, 2022 & 322nd meeting held on November 23-24, 2020, and the Committee decided as under:-

"The original file of the institution along-with other related documents were carefully considered and examined by WRC in the Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. Recognition was granted to the institution on 01.07.2008 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.

2. The institution has not shifted the institution in its own premises till date.

3. Accordingly, Show Cause Notice was issued to the institution on 09.10.2020.

4. The institution has not submitted the reply of the Show Cause Notice till date.

In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be WITHDRAWN under clause 7(15) from the next academic session 2021-22."

8. AND WHEREAS, Withdrawal order was issued to the institution on 10.12.2020.

9. AND WHEREAS, the institution had filed an appeal against the Withdrawal order dated 10.12.2020 and the Appellate Authority vide order dated 10.09.2021 remanded back the case to the WRC, NCTE.

10. AND WHEREAS, the institution had also approached the Hon'ble High Court of Judicature at Aurangabad Bench at Aurangabad vide Writ Petition No.12583/2021 and the Court had passed an order dated **30.11.2021.**

11. AND WHEREAS, the matter was considered by the WRC in its 348th meeting held on December 12, 2021 and the Committee decided as under:-

"The original file of the Institution, along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The WRC considered the order dated 30th November 2021 passed by High Court of Judicature at Bombay Bench at Aurangabad in W.P. No. 12583 of 2021 and examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the institution for B.Ed. course be restored.

12. NOW THEREFORE, Recognition of the LATE DAGADABAI CHAMPALALJI BIYANI SHAIKSHANIK VIKAS, BHUSAWAL SANCHALIT BIYANI B.Ed. COLLEGE, AT. MIRGAVHAN, NEAR GOVT. ITI, JAMNER ROAD, BHUSAWAL, JALGAON-425201, MAHARASHTRA for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) is hereby restored.
