**RESTORATION ORDER**

**WHEREAS**, recognition was granted to the institution, namely to **SIT COLLEGE OF EDUCATION, KHASRA NO.-152/1, 152/3, VIL- JAMODI SENGRAN, P.O- SIDHI, TEH-GOPAD BANAS, SIDHI, MADHYA PRADESH** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/5-6/WRCAPP2274/223/201/MP/2013/115279-115286 dated 24-02-2014.

**AND WHEREAS**, Revised Recognition order was issued to **SIT COLLEGE OF EDUCATION, KHASRA NO.-152/1, 152/3, VIL- JAMODI SENGRAN, P.O- SIDHI, TEH- GOPAD BANAS, SIDHI, MADHYA PRADESH**, vide order No. WRC/APP2274/223/201/2015/137137-137145 dated 26-05-2015 for B.Ed. (URDU) of Two Years Duration with an annual intake of 100 students for two basic units of (50 students each) from the academic session 2015-2016.

**AND WHEREAS**, Compliance was not submitted as per regulations 2014.

**AND WHEREAS**, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

**AND WHEREAS**, a Show Cause notice was issued to the institution on 28.02.2017 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order:

**AND WHEREAS**, the reply of show cause notice was not submitted by the institution.

**AND WHEREAS**, the matter was placed in 310<sup>th</sup> Meeting held on August, 19-21 2019 of WRC and the Committee decided that "The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The Show Cause Notice was issued to the institution vide letter dated 28/02/2017 The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice.

**Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."**

**AND WHEREAS**, the Withdrawal order was issued to the institution on 05.09.2019.

**AND WHEREAS**, the institution filed an Appeal to the Council on 02.11.2019 and the Council vide its order dt. 03.03.2020 remanded back the case to the WRC, NCTE for necessary action and accordingly the institute submitted related documents in WRO vide letter dt 18.04.2020.

**AND WHEREAS**, the matter was placed in 316<sup>th</sup> Meeting held on 27-28 August & 04 September 2021, of WRC and the Committee decided:

"... The Committee considered the matter in view of the order of the Appellate Authority, Agenda Note and observed the follow:-

- The institution has not submitted the additional FDR for Rs. 4.00 lakhs.

**In view of the above, the Committee decided that last opportunity be given to the institution to submit documents within 30 days u/s 17 of the NCTE Act for B.Ed. course.**

**AND WHEREAS**, the Final Show Cause Notice was issued to the institution on 18.09.2020, and its reply received on 26.10.2020.

**AND WHEREAS**, the matter was placed in 345<sup>th</sup> Meeting held on 01-02 November, 2021 of WRC and the Committee decided that:-

"...This is a RPRO case and same was remanded back by the appellate authority.

**The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the University for B.Ed course with an annual intake of 100 students (two units of 50 students each) be restored."**

**NOW THEREFORE**, recognition dated 24-02-2014 and revised recognition order dt. 26-05-2015 issued to the institution viz **SIT COLLEGE OF EDUCATION, KHASRA NO.-152/1, 152/3, VIL- JAMODI SENGRAN, P.O- SIDHI, TEH- GOPAD BANAS, SIDHI, MADHYA PRADESH** for B.Ed. course is hereby restored permitting the total annual intake of 100 (two units of 50 students).
