Order

WHEREAS, recognition was granted to the institution, namely, SAFIA COLLEGE OF SCIENCE & EDUCATION, SAFIA COLLEGE ROAD, BHOPAL- 462001, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. course (100 Intake) vide order dated 07.05.1999, & 29.12.2000.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 03-02-2015.

3. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 31.05.2015.

4. AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. AND, WHEREAS, a Show cause notice was issued to the institution on 20.07.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

1) Staff Profile for the session 2015-16 duly approved by the affiliating body.

2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

6. AND WHEREAS, the reply of show cause notice was submitted by the institution on 10.08.2016.

7. AND WHEREAS, the matter was placed in 284th Meeting of WRC held on November 28th-29th, 2017 and the Committee decided that "... In response to the Show Cause Notice dated 20.07.2016, the institution has submitted a list of 1+10 faculty members, which is not approved by the competent authority. Further, a few of the staff members do not have the required percentage of marks (55%). The staff profile as per Appendix-IV of NCTE Regulations, 2014, approved by the affiliating body should be submitted in original.

Secondly, Building Completion Certificate signed by a Govt. Engineer and FDRs of Rs.12.00 lakhs (in joint name) should be submitted in original.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

8. AND WHEREAS, the clarification letter was issued to the institution on 01.12.2017 and reply was submitted by the institution on 02.01.2018.

9. AND WHEREAS, the matter was placed in 301st Meeting of WRC held on January 17th-18th 2019 and the Committee decided that "...Consequent to the issue of Revised Recognition order, Show Cause Notice dated 20.07.2016 followed by Clarification letter dated 01.12.2017 were issued.

The institution in its reply dated 30.12.2017 has submitted a photocopy of staff list, which is not approved by the competent authority. Building Completion Certificate duly signed by the Government Engineer not submitted. Endowment and Reserve funds not sufficient for two courses (B.Ed. and M.Ed.).

Hence, Recognition is withdrawn from the academic session 2019-2020. FDRs, if any, be returned.

File for M.Ed. course be put up in the next meeting."

10. AND, WHEREAS, the withdrawal order was issued to the institution on 25.01.2019. The institution filed an Appeal to the NCTE, Hqrs. on 19.03.2019 and the Appeal Committee vide its order dated 14.05.2019 the Council hereby remanded back the case to the WRC, NCTE for necessary action and accordingly the appeal order institute submitted related documents in WRO vide letter dated 21.05.2019 & 22.05.2019 received on 23.05.2019.

11. AND WHEREAS, the matter was placed in 309th Meeting held on July 23rd-26th, 2019 of WRC and the Committee decided that "...The committee considered case in the light of the order dated 12/07/2019 passed by the Hon'ble High Court of Delhi in W.P. No. 6786/2019 and appeal order dated 14/05/2019.
