CONTINUE ORDER

WHEREAS, recognition was granted to the institution namely, **CHATRPATI SHAJUJI SHIKSHA MAHAVIDYALAYA, PLOT NO. 216/1, 216/2, 217/2, RATAHRI, P.O.- RATAHRA, TEH-HUZUR, DISTRICT- REWA-486001, MADHYA PRADESH** under section 14(1) of the NCTE Act, 1993 for conducting **B.ED. (CO.ED)** course of one year duration with an annual intake of 100 Students vide order No. WRC/APP190/223rd/B.Ed/2014/116187-88,90,91,93,95,96,97,98 dated 03.03.2014.

AND WHEREAS, the revised recognition order was issued to **CHATRPATI SHAJUJI SHIKSHA MAHAVIDYALAYA, PLOT NO. 216/1, 216/2, 217/2, RATAHRI, P.O.- RATAHRA, TEH-HUZUR, DISTRICT- REWA-486001, MADHYA PRADESH** vide order No. WRC/APP190/223/203/2015/137803, 807,808,809,810,811,813,815,816 dt. 27.05.2015 for B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided "...issued Show Cause Notice to the institution of the condition maintained in revise order."

AND WHEREAS, recognition was granted to the institution namely, **CHATRPATI SHAJUJI SHIKSHA MAHAVIDYALAYA, PLOT NO. 216/1, 216/2, 217/2, RATAHRI, P.O.- RATAHRA, TEH-HUZUR, DISTRICT- REWA-486001, MADHYA PRADESH** vide order No. WRC/APP190/223/203/2015/137803, 807,808,809,810,811,813,815,816 dt. 27.05.2015 for B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

AND WHEREAS, a Show cause notice was issued to the institution on 10.02.2017 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order.

- 1) Staff Profile for the session 2015-2016 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

AND WHEREAS, the matter was placed in 310th Meeting held on August 19-21, 2019 and the Committee decided that "The Show Cause Notice was issued to the institution vide letter dated 10/02/2017. The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice. Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS, the Withdrawal order was issued to the institution on 05.09.2019.

AND WHEREAS, the institution has filed W.P. 10412/2019 in the High Court Of Delhi At New Delhi passed an order dt. 25.09.2019.


AND WHEREAS, the matter was placed in 312th Meeting held on January 27-29, 2020 and the Committee decided that "The Committee studied the decision of the Hon'ble High Court in the W.P. No. 10412/2019 & CM Appl No. 42994/2019. The Committee decided that

- A copy of SCN dated 10.02.2017 may be sent to the institution again.
- The representative of the institution be given personal hearing in the next meeting of WRC. The date of the personal hearing will be intimated later.

The representative alongwith all the requisite documents be remain present."

AND WHEREAS, Clarification letter was issued to the institution dt. 12.02.2020.

AND WHEREAS, the matter was placed in 313th Meeting held on February 25-27, 2020 and the Committee decided that "As per the decision of WRC in its 312th meeting in compliance of the

Court directions, the representatives of the institution appeared before WRC for personal hearing on 26/02/2020. It is decided after the discussion that the representative of the institution will submit the required documents today itself."

AND WHEREAS, the institution has submitted documents on 27.02.2020 & 05.03.2020.

AND WHEREAS, the Matter was considered by WRC in its 315th Meeting held on August 10-11 & 14 2020 and WRC decided that "This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing. The personal hearing of the institution was held on 26th February 2020, wherein the petitioner wherein the petitioner informed that it had submitted certain documents to WRC Office. The WRC examined the documents submitted by the institution and observed the following deficiencies :- • **Additional FDRs for Rs. 4 lakhs in original not submitted. In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act.**"

AND WHEREAS, Show Cause Notice was issued dt. 26.08.2020 & reply received from the institution on 08.09.2020.

AND WHEREAS, the institution has again filed W.P. 5323/2021 in the High Court Of Delhi At New Delhi passed an order dt. 17.05.2021.


AND WHEREAS, a letter was issued to the Higher Education Department, to add name of the institution in recognition list of the NCTE WRC for session 2021-22 vide its letter dt. 14.07.2021.

AND WHEREAS, the Matter was considered by WRC in its 341st Meeting held on August 17-18, 2021 and WRC decided that "The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

Recognition of the institution be continued for the B.Ed. programme with an annual intake of 100 (two basic units)"

NOW THEREFORE, the recognition of **CHATRPATI SHAJUJI SHIKSHA MAHAVIDYALAYA, PLOT NO. 216/1, 216/2, 217/2, RATAHRI, P.O.- RATAHRA, TEH-HUZUR, DISTRICT- REWA-486001, MADHYA PRADESH** for conducting **B.Ed. (CO.ED)** course is permitted to **Continue** with an annual intake of 100 students (two basic units of 50 each).


