WHEREAS, recognition was granted to the institution namely **SWAMI VIVEKANAND COLLEGE**, **RUN BY PRAKHAR PRAGYA SHIKSHA PRASAR EVAM SAMAJ KALYAN SAMITI, 224 YADAV COLONY, SAGAR CANTT, SAGAR-470001, MADHYA PRADESH** vide Order No. WRC/5-6/106th/2008/40174 dated 28.08.2008 for **M.Ed.** course of one (1) year duration with an annual intake of 25 students and enhancement of intake was permitted vide order No. WRC/APW06671/225118/140th/2010/73522-73528 dated 11.01.2011 from 25 to 35 seats.

AND WHEREAS, the revised order was issued to the institution vide order no. WRC/APW06671 /225118/ $\{M.P.\}$ /2015/146833 dt. 31.05.2015 for conducting M.Ed. programme of two (2) years duration with an annual intake of 50 students (one unit) from the academic session 2015-16.

AND WHEREAS, the institution has submitted documents in response to Compliance of revised recognition order dt. 31.05.2015.

AND WHEREAS, The matter was considered in WRC in its 304th meeting held on April 02-04, 2019 and the Committee decided that:-" The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

The revised recognition order was issued to the institution on 31/05/2015. The institution has submitted reply dated 26/10/2015 received in the office of WRC on 29/10/2018

On perusal of the reply of the institution it is observed that the institution has not submitted the following documents:

- The institution has not submitted any proof of additional built up area.
- The institution has not submitted any proof of additional infrastructure.
- The institution has not submitted a letter granting approval for the selection or appointment of faculty, issued by the affiliating body as per NCTE Regulations 2014
- The institution has not submitted NEC issued by the competent authority.
- The institution has not submitted land use certificate issued by the competent authority.
- The institution has submitted copy of building plan but Plot/khasra Number, total land area and earmarked area for each course being run in the same premises not mentioned and not proper readable.
- The institution has not submitted BCC issued by the competent authority.
- The institution has not submitted certified registered land document. The land khasra No. 608, 606 area 0.97 Hect. Submitted by the institution are in favour of Sachiv, Ajay Kumar Tiwari, which is not as per Regulations.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for M.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS, Withdrawal order was issued to the institution on 12.04.2019.

AND WHEREAS, the institution has filed an appeal to NCTE, Hqrs. on 10.05.2019. The Appellate Authority vide its appeal order dated 30.07.2019 remanded back the case to the WRC, NCTE, for necessary action.

AND WHEREAS, the matter was placed in 313rd Meeting of WRC held on 25-27 February, 2020 and the Committee decided that:-" The Committee considered the matter keeping in view the directions of the Appellate Authority order dated 30.07.2019 and decided that Show Cause Notice u/s 17 of the NCTE Act be issued on the institution on following grounds:-

- (i) The institution has not submitted any proof of additional built-up area.
- (ii) The institution has not submitted nay proof of additional infrastructure.
- (iii) The institution has not submitted a letter granting approval for the selection or appointment of faculty, issued by the affiliating body as per NCTE Regulations, 2014.
- (iv) The institution has not submitted NEC issued by the Competent Authority.
- (v) The institution has not submitted land use certificate issued by the Competent Authority.
- (vi) The institution has submitted copy of building plan but Plot/Khasra Number, Total land area and earmarked area for each course being run in the same premises not mentioned and not proper readable.
- (vii) The institution has not submitted BCC issued by the competent authority.
- (viii) The institution has not submitted certified registered land document. The land Khasra No. 608, 606 area 0.97 Hect. Submitted by the institution are in favour of Sachiv, Ajay Kumar Tiwari, which is not as per Regulations.

In view of the above, a Show Cause Notice be issued u/s 17 of the NCTE Act to the institution to reply within 30 days."

AND WHEREAS, Show Cause Notice was issued to the institution dt. 16.03.2020 and reply received on 06.03.2020 & 21.08.2020.

AND WHEREAS, the institution has filed W.P. 5549/2020 in the High Court of Delhi, Bench at New Delhi passed an order dt. 24.08.2020.

AND WHEREAS, a letter was issued to the Higher Education Department, to add name of the institution in recognition list of the NCTE WRC vide its letter dated 31.08.2020.

AND WHEREAS, the matter was placed in 317th Meeting of WRC held on 28 & 30 September, 2020 and the Committee decided that:-" The Committee considered the matter keeping in view the directions of the Hon'ble Court in W.P. No. 5549/2020 and CM No. 20014-15/2020 and noted that as per the direction of the Hon'ble Court, the name of this institution has been updated on the website of NCTE and also the letter to the State Government has been sent.

The WRC examined the reply submitted by the institution and observed the following :-

- The site plan duly earmarked land and built up area for all the courses being run in the institution has not been submitted.
- The approval letter of the University for approval of the staff appointed has not been submitted.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act."

AND WHEREAS, Final Show Cause Notice was issued to the institution dt. 14.10.2020 and reply received on 02.11.2020.

AND WHEREAS, the matter was placed in 324th Meeting of WRC held on 23-24 & 31 December, 2020 and the Committee decided that:- " The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The institution has submitted all required documents which were considered by the Committee and found fit the case for issuance of Final Recognition orcier for one unit.

In view of above, the Committee decided as under:

Recognition of the institution be continued for the M.Ed. programme with an intake of one unit of 50 students."
