**RESTORATION ORDER**

WHEREAS, recognition was granted to the institution, namely to **DR. BABASAHEB AMBEDKAR KHADI GRAMUDYOG SANGH'S, SMT. GEETA BANKAR MAHILA SHIKSHAN SHASTRA MAHAVIDYALAYA, VASUD ROAD, EAST SIDE, BORADE BUILDING SANGAOLA, DIST-SOLAPUR, MAHARASHTRA** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course, with an annual intake of 100 students (Two basic unit of 50 students each) vide order No. WRC/2-32/123168/69/2005/4230 dated 17.05.2005.

2. **AND WHEREAS**, Revised Recognition order was issued to **DR. BABASAHEB AMBEDKAR KHADI GRAMUDYOG SANGH'S, SMT. GEETA BANKAR MAHILA SHIKSHAN SHASTRA MAHAVIDYALAYA, VASUD ROAD, EAST SIDE, BORADE BUILDING SANGAOLA, DIST-SOLAPUR, MAHARASHTRA** vide order No. F.No. WRC/APW000834/123168/2015/142851- 143010 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic unit of (50 students each) from the academic session 2015-2016.

3. **AND WHEREAS**, Compliance was not submitted as per regulations 2014.

4. **AND WHEREAS**, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. **AND WHEREAS**, a Show Cause notice was issued to the institution on 23.12.2016 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.

6. **AND WHEREAS**, the reply of show cause notice was submitted by the institution on 12.01.2017.

7. **AND WHEREAS**, vide Order dt. 01.02.2017 NCTE has reduced intake from Two(2) units(100 students) to one (1) unit (50 students) to conduct of B.Ed. course.

8. **AND WHEREAS**, the matter was placed in 316<sup>th</sup> Meeting held on August 27-28, & September 03<sup>rd</sup> 2020 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision."





9. **AND WHEREAS**, a Show Cause Notice was issued to the institution on 09.10.2020 as per decision of WRC, and its reply not received by the institution.

10. **AND WHEREAS**, the matter was placed in 321<sup>st</sup> Meeting held on November 09-11, 2020 of WRC and the Committee decided that.

*"... The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:*

*1. Recognition was granted to the institution on 17.05.2005 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.*

*2. The institution has not shifted the institution in its own premises till date.*

*3. Accordingly, Show Cause Noted was issued to the institution on 09.10.2020.*

*4. The institution has not submitted the reply of the Show Cause Notice till date.*

***In view of above, the Committee decided that the recognition of B.Ed programme of the institution be WITHDRAWN under Section 17 of NCTE Act from the next academic session 2021-21"***

11. **AND WHEREAS**, the Withdrawal order was issued to the institution on 19.12.2020.

12. **AND WHEREAS**, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 10263/2021 dt. 15.09.2021. the operative part is produced here below:-

*In the present case, however, neither has the petitioner sought the order of restoration of recognition in terms of the aforesaid order dated 30.07.2021, not has the NCTE complied with the orders dt 12.01.2021 read with order dated 30.07.2021. the petitioner ought to have made a representation in this regard as contemplated by the order dated 30.07.2021, so that the respondent could have issued the necessary order. Be that as it may, the order of withdrawal having been quashed, and the status of the petitioner as a recognized institution having been restored, the NCTE is directed to issue the order of restoration of recognition within one week from today. The NCTE will also reflect the name of the petitioner as a recognized institution on its website and communicate the same to the affiliating body as well as the concerned State-Government within the same period.*


*The writ petition is disposed of with these direction.*

13. **NOW THEREFORE**, recognition of the institution viz **DR. BABASAHEB AMBEDKAR KHADI GRAMUDYOG SANGH'S, SMT. GEETA BANKAR MAHILA SHIKSHAN SHASTRA MAHAVIDYALAYA, VASUD ROAD, EAST SIDE, BORADE BUILDING SANGAOLA, DIST-SOLAPUR, MAHARASHTRA** for B.Ed. course with an annual intake of 50 students (one unit) is hereby restored.

14. The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dt. 31.05.2015.

15. The office order F.No.WRC/APW000834/123168/B.Ed./M.H./2021/218423-427 dt. 25.11.2020 be treated as cancelled.
