RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely to VIVEK VARDHANI COLLEGE OF EDUCATION FOR WOMEN, 8-GC, INDUSTRIAL, STADIUM ROAD, NANDED, MAHARASHTRA under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed.course, with an annual intake of 100 students (Two basic units of 50 students each) vide order No. APW02489/122398 / 113066/WRC/5-6/92/2006/12587 dated 08.03.2007.

2. **AND WHEREAS,** Revised Recognition order was issued to **VIVEK VARDHANI COLLEGE OF EDUCATION FOR WOMEN, 8-GC, INDUSTRIAL, STADIUM ROAD, NANDED, MAHARASHTRA** vide order F.NO. F.NO.WRC/APW01925/113066/2015/146253-146260 dated 31-05-2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic unit of (50 students each) from the academic session 2015-2016.

3. AND WHEREAS, Compliance was not submitted as per regulations 2014.

4. **AND WHEREAS,** the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. **AND WHEREAS,** a Show Cause notice was issued to the institution on 27.02.2017 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.

6. AND WHEREAS, the reply of show cause notice was not submitted by the institution.

7. **AND WHEREAS**, the matter was placed in 311th Meeting held on September 25-27, 2019 of WRC and the Committee decided that:

"... The Show Cause Notice was issued to the institution vide letter dated 27/02/2017.

The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

- 8. AND WHEREAS, the Withdrawal order was issued to the institution on 14.10.2019.
- AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi.
 W.P. (C) No. 1127/2019 & CM APPL. 46456/2019 dt. 20.011.2019.
- 10. **AND WHEREAS,** the matter was placed in 312th Meeting held on January 27-29, 2020 of WRC and the Committee decided that.
 - "...The Committee studied the decision of the Hon'ble High Court in the W.P. No. 11271/2019 & CM Appl No. 46456/2019. The Committee decided that
 - A copy of SCN dated 27.02.2017 may be sent to the institution again.
 - The representative of the institution be given personal hearing in the next meeting of WRC. The date of the personal hearing will be intimated later.

The representative alongwith all the requisite documents be remain present."

11. AND WHEREAS, a letter was issued to the institution on 07.02.2020.

12. **AND WHEREAS,** the matter was placed in 313th Meeting held on February25-27, 2020 of WRC and the Committee decided that.

"...As per the decision of WRC in its 312th meeting in compliance of the Court directions, the representatives of the institution appeared before WRC for personal hearing on 26/02/2020. It is decided after the discussion that the representative of the institution will submit the required documents on or before 9th March, 2020"

- 13. AND WHEREAS, the institution has submitted the replyon 11.03.2020.
- 14. **AND WHEREAS,** the matter was placed in 315th Meeting held on August10-11 & 14, 2020 of WRC and the Committee decided that.

"... This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing.

The personal hearing of the institution was held on 26th February 2020, wherein the petitioner was directed to submit the required documents to WRC Office. The institution had submitted the documents to WRC on 11th March 2020.

The WRC examined the documents submitted by the institution and observed the following deficiencies :-

- The submitted staff list is not approved by the affiliating body.
- The institution is required to submit the notarised translated version of land documents.
- Original FDRs for Rs. 12 lakhs towards Endowment and Reserve Fund not submitted.
- The institution has not submitted the Land Use Certificate, Non Encumbrance Certificate and Building Completion Certificate as asked for in the SCN dated 27th Feb 2017.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act."

- 15. **AND WHEREAS,** the Final Show Cause Notice was issued to the institution on 02.09.2020 and its reply received on 29-09-2020.
- 16. **AND WHEREAS,** the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 13273/2021 with CM APPL.41884/2021 dt. 25.11.2021 the operative part is produced here below:-

"...The petitions are, therefore, allowed and the NCTE is directed to issue orders of restoration recognition. The petitioners will be permitted to participate in counselling and admit students for the year 2021-22and also for subsequent years, until and unless a fresh withdrawal order is passed against them. The status of the petitioners as recognised institution will be communicated by the NCTE to the petitioners affiliating university as well as to the concerned departments of the State Government. The respondents ae directed to comply with these directions within one week."

- 17. NOW THEREFORE, recognition of the institution viz VIVEK VARDHANI COLLEGE OF EDUCATION FOR WOMEN, 8-GC, INDUSTRIAL, STADIUM ROAD, NANDED, MAHARASHTRA for B.Ed. course with an annual intake of 100 students (Two basic units of 50 students of each) is hereby restored.
- 18. The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dt. 31.05.2015.
