Restoration order

WHEREAS, the institution, namely, Awdhesh Pratap Singh Vishwvidhyalaya, Rewa, Madhya Pradesh was granted recognition for B.Ed. Course of one year duration by WRC NCTE vide Order No.WRC/5-6/88/2006 dated 15.09.2006.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 vide Order No.WRC/APW03409/223450/88/2015/136816-824 dated 25.05.2015.

3. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order was considered by WRC in its 255th meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice under Section 17(1) was issued to the institution dated 20.09.2016.

4. **AND WHEREAS**, in response to the aforesaid letter, the institution did not submit any reply.

5. **AND WHEREAS**, the matter was considered by WRC in its 268th meeting held on February 9-11, 2017 wherein Committee decided that show cause notice be issued to the institution as to why the number of units in the B.Ed. course, which was given by revised order, should not be reduced/reversed. Accordingly, show cause notice under Section 17(1) was issued to the institution dated 15.02.2017.

6. **AND WHEREAS**, the matter was considered by WRC in its 285th meeting held on 19th-21st December, 2017 and the Committee decided as under:

"The case file was seen. In response to the Show Cause Notice dated 20.09.2016, the institution replied vide letter dated 30.03.2017. Before the case can be considered further, it is necessary that the University create a Department of Education and appoint staff on regular basis."

Accordingly, the institution was informed vide letter dated 29.12.2017.

7. **AND WHEREAS**, in response to the aforesaid letter, the institution did not submit any reply.

8. **AND WHEREAS**, the matter was considered by WRC in its 310th meeting held on 19th-21st August, 2019 and the Committee decided as under:

"The Show Cause Notice was issued to the institution vide letter dated 15/02/2017 and reply was received on 27/03/2017.

The summary of the case submitted on 27/03/2017 reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.

Moreover, the staff profile of 1+8 faculty members is insufficient and not in original for approved intake of two basic units.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

Accordingly, withdrawal order was issued to the institution vide Order No. WRC/APW03409/223450/B.Ed./310th/2019/205855 to 205861 dated 04.09.2019.

9. **AND WHEREAS**, the institution has filed an appeal to NCTE Hqrs against withdrawal order dated 04.09.2019 and the Appellate Authority vide order dated 05.12.2022 decided as follows:

"After perusal of the Memoranda of Appeal, affidavit, the documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to WRC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The WRC is at a liberty to verify the submitted documents from the concerned issuing authority."

10. **AND WHEREAS**, the matter was considered by WRC in its 379th meeting held on 17th January, 2023 and the Committee decided as under:

"The original file of the Institution along-with other related documents, were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- *Recognition was granted for B.Ed. course vide order dated 15.09.2006.*
- *Revised order was issued dated 25.05.2015 in pursuance of NCTE Regulations, 2014.*
- *Recognition for B.Ed. course was withdrawn vide order dated 04.09.2019.*
- *Matter remanded back vide order dated 05.12.2022 passed by NCTE Appellate Authority.*

- Documents submitted by the institution in compliance of appellate order was considered by WRC.

In view of the above, the Committee decided that recognition for B.Ed. course be restored. A copy of restoration order be also uploaded on the WRC web portal on NCTE website.

The Committee further observed after considering the documents submitted by the institution in compliance of appellate order that the institution was still deficient on the following grounds:

- List of faculty in accordance with NCTE, 2017 Norms and Standards
- Building Completion Certificate
- Building Plan
- Non -Encumbrance Certificate (issued by Competent Authority)
- C.L.U.

In view of the above, the Committee decided that a Show Cause Notice prior to the withdrawal of recognition be issued to the institution u/s 17 of the NCTE Act to submit a reply accompanied by an original affidavit within 30 days from the date of uploading of minutes on the website failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations."

11. **NOW THEREFORE**, recognition of Awdhesh Pratap Singh Vishwvidhyalaya, Rewa, Madhya Pradesh for conducting B.Ed programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) is hereby restored till a fresh withdrawal order is issued by WRC, NCTE.

12. The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dated 25.05.2015.
