## **CONTINUE ORDER**

WHEREAS, recognition was granted to the institution namely SMT. S.N. PATEL B.ED COLLEGE, SHARDA SIKSHAN TIRTH BHAVAN, OPP. NEW CIVIL HOSPITAL ASWARA AHMEDABAD-16, GUJARAT vide Order No. WRC/5-6/98th/2007/C-19453 dated 11.07.2007 for B.Ed. course of One (1) years duration with an annual intake of 100 students (Two basic units of 50 each).

AND WHEREAS, the revised recognition order was issued to the institution namely SMT. S.N. PATEL B.ED COLLEGE, SHARDA SIKSHAN TIRTH BHAVAN, OPP. NEW **GUJARAT** AHMEDABAD-16, WRC/APW04074/323399/2015/145146 dated 31.05.2015 for **B.Ed.** Programme of two years duration with an annual intake of 100 students from the academic session 2015-16 with certain conditions.

AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied

AND WHEREAS, a Show Cause notice was issued to the institution on 05.08.2016 for not NCTE Regulations, 2014." submitting the documents in compliance of Regulation 2014 mentioned in the revised order.

AND WHEREAS, reply received on dated.11.08.2016 from the institution. The matter was placed in 277<sup>th</sup> WRC meeting held on June 29<sup>th</sup>-30<sup>th</sup>, 2017 and the Committee observed that:

"...The case file was seen. In response to the WRC letter dt. 05/08/2016, regarding fulfillment of requirements, the institution has not submitted list of teaching staff duly approved by the affiliating body, for t unit of the B.Ed. course.

As per NCTE Regulations, 20t4, FDRs for 12 lakhs in joint operation with the RD, WRC is required . The institution should also fulfill this condition.

Show Cause Notice be issued on the above grounds. Reply should be received within 1 month."

Accordingly, Show Cause notice was issued to the institution on 05.07.2017

AND WHEREAS, reply received on dated.01.09.2017 from the institution.

AND WHEREAS, the matter was placed in 284th WRC meeting held on November 28-29, 2019 and the Committee observed that:-

"...The case file was seen. The institution has submitted a list of staff members who re appointed on adhoc basis from year to year. It may be clarified whether these faulty members are full-time or part-time. Since, the institution has only 1+7 teaching faculty, the intake will be reduced to one unit. Secondly, building Completion Certificate signed by a Govt. Engineer and FDRs of Rs. 12 lakhs (in joint name) should be submitted in original. Compliance should be submitted by the Institution within one month,

failing which Recognition will be withdrawn."

Accordingly, a letter was issued to the institution on 05.12.17

AND WHEREAS, reply received on dated 22.12.2017

AND WHEREAS, The matter was placed in 336<sup>th</sup> WRC meeting held on March 24<sup>th</sup> – 25<sup>th</sup>, 2021 and the Committee observed that:

"...The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and

Guidelines issued by NCTE from time to time and the following observation was made that:

(a) The institution is required to submit the certified copy of the land documents.

(b) The institution is required to submit the a copy of Non – Encumbrance Certificate issued by the competent authority.

(c) The institution is required to submit the original blue print of the Building Plan

issued by the concerned competent authority.

(d) The institution is required to submit the Land Possession Certificate issued by the competent authority.

Hence, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act 1993 to submit the notarized / certified documents on the above-mentioned grounds within 30 days from the date of issue of this Final Show Cause Notice.

**Accordingly**, show cause notice was issued to the institution on 07.04.2021 and its reply received on 29.04.2021

Accordingly, reply received on date 29.4.2021

**AND WHEREAS**, the matter was placed in 345<sup>th</sup> WRC meeting held on November 01-02, 2021 and the Committee observed that:

"...The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under: Recognition of the institution be continued for the B.Ed programme with an intake of two units of 50 students each."

NOW THEREFORE, the recognition of SMT. S.N. PATEL B.ED COLLEGE, SHARDA SIKSHAN TIRTH BHAVAN, OPP. NEW CIVIL HOSPITAL ASWARA AHMEDABAD-16, GUJARAT for conducting B.Ed. course is permitted to Continue with an intake of two units of 50 students each.
