REVISED ORDER

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993, and in supersession of the National council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. The Recognition was granted to the institution namely, **Suvidha Mahila College, Shri Suvidha Education Trusts, Heduva- Rajgar, Sametra PO, Mehsana- 3840001, Gujarat**, for **B.Ed**. Course vide order No. WRC/5-6/40/2002/05843 dt. **24.09.2002** with an annual intake of 100 students.
- 3. And whereas, order dt. 17.09.2021 passed by Hon'ble High Court of Delhi at New Delhi in W.P. (C) No. 10458/2021 was placed in $351^{\rm st}$ meeting of the WRC held on $4^{\rm th}$ to $5^{\rm th}$ February, 2022 and the Committee decided as follows:-
 - "1. The Recognition was granted to the institution on 24.9.2002 for B.Ed. one year programme with an intake of 100 students and on 8.8.2009 for M.Ed. programme with an annual intake of 25 students.

2. After promulgation of NCTE Regulation 2014 Revised Recognition order was not issued for two year B.Ed. and M.Ed. programme due to non-submission of

affidavit by the institution.

3. The institution has submitted annexed an affidavit in the writ petition on 7.1.2015 for acceptance of NCTE Regulation 2014 with a request to issued revised Recognition order for B.Ed. and M.Ed. two-year programme with an intake of 100 and 50 seats respectively.

4. The Hon'ble High Court of Delhi at New Delhi in W.P. (C) 10458/2021 has

directed that the

institution may be treated as recognized institution and respondents are directed to take consequential steps, including modification of their website to reflect the status of the institution.

In view of above, the Committee considered the directions of the Hon'ble High Court and decided that the Revised Recognition Order for B.Ed. and M.Ed. two-year programme with an annual intake 100 and 50 students respectively be issued to the institution."

4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western, Regional Committee (NCTE) hereby issues the revised recognition order to Suvidha Mahila College, Shri Suvidha Education Trusts, heduva- Rajgar, Sametra PO, Mehsana- 3840001, Gujarat, for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two units of 50 students each).

- 5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 7. The institution shall maintain & update its we-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

a) Sanctioned programmes along with annual intake in the institution:

b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

c) Name of faculty members who left or joined during the last, quarter:

d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:

e) Fee charged from students;

f) Available infrastructural facilities;

g) Facilities added during the last quarter;

h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

i) The affidavit with enclosure submitted along with application.

- j) The institution shall be free to post additional relevant information. If it so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 8. If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

Recognition order WRC/5-6/40/2002/05843 dt. 24.09.2002 be treated as cancelled from the date if issue of this revised order.
