RADHA SWAMY SATSANG KHANDWA ROAD, INDORE-452017, MADHYA PRADESH, vide order No. F.No. WRC/APW04328/225046/M.P./2015/138938-1698 dated 31.05.2015 for M.Ed. of Two Years Duration with an annual intake of 50 students for one basic unit of (50 students) from the academic session 2015-2016.
- 3. AND WHEREAS, Compliance was not submitted as per regulations 2014.
- AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN
- 5. AND WHEREAS, Show Cause notice was issued to the institution on 06.01.2017 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order:
- AND WHEREAS, the reply of show cause notice was submitted by the institution on 17.01.2017.
- 7. AND WHEREAS, the matter was placed in 296th Meeting held on August 28-29, 2018 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and

"The case file was seen. Revised Recognition order dated 31.05.2015 was issued to the institution followed by a Show Cause Notice dated 06.01.2017. The institution replied vide letter dated 19.01.2017.

It has not submitted staff profile approved by the affiliating body, Building Completion Certificate and

Hence, compliance letter be issued to the institution. Reply should be submitted within one month, failing which Recognition will be withdrawn."

- 8. AND WHEREAS, the letter was issued to the institution on 06.09.2018 as per decision of WRC, and its reply received from the institution on 06.09.2018.
- 9. AND WHEREAS, the matter was placed in 311th Meeting held on September 25-27, 2019 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"The compliance letter was issued to the institution on 06/09/2018. The institution has submitted reply on 06/09/2018.

On perusal of the reply of the institution the committee observed that:

- The institution has submitted photo copy staff profile singed by Registrar, Devi Ahilya University, Indiore, one Principal, two professor, two Associate Professor, three assistant professor which not as per NCTE Regulations, 2014.
- The institution has not submitted original Staff profile issued by the affiliating University along with approval letter issued by the competent authority as per NCTE Regulations, 2014.

The institution has not submitted FDRs Rs. 5+7 lakhs in original.

In view of the above, a Show Cause Notice be issued u/s 17 of the NCTE Act to the institution

- AND WHEREAS, the Show Cause Notice was issued to the institution on 16.03.2020 as per decision of WRC, and its reply received from the institution on 18.05.2020.
- AND WHEREAS, the matter was placed in 321th Meeting held on November 09-11, 2020 of WRC and the Committee decided that" The original file of the Institution alongwith other related documents, NCTE Ac 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following the follow the following observations were made: -
  - The faculty appointed at Sr. 7 (Mr. Ridhi Chand Gupta) has not NET/Ph.D qualification which mandatory as per NCTE Regulation 2014 and amended Regulation 09.06.2017. Hence, he is r In view of the above, the Committee decided that last opportunity be given to the institution
