RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to **MAYARAM MAHAVIDYALAYA, RUN BY SWARGIYA BAIS MAYARAM SHIKSHA SAMITI, PLOT NO- 61/2, MEDHAULI - MORWA, SINGRAULI, SIDHI, MADHYA PRADESH** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. APW06080/223677/WRC/5-6/105/2008/39137-39- dated 18.08.2008.

2. **AND WHEREAS**, Revised Recognition order was issued to **MAYARAM MAHAVIDYALAYA, RUN BY SWARGIYA BAIS MAYARAM SHIKSHA SAMITI, PLOT NO- 61/2, MEDHAULI - MORWA, SINGRAULI, SIDHI, MADHYA PRADESH**, vide order No. WRC/APW06080/223677/2015/144017-144035 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic units of (50 students each) from the academic session 2015-2016.

3. **AND WHEREAS**, Compliance was not Submitted as per regulations 2014.

4. **AND WHEREAS**, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. **AND WHEREAS**, a Show Cause notice was issued to the institution on 21.12.2016 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order:

6. **AND WHEREAS**, the reply of show cause notice was submitted by the institution on 06.02.2017.

7. **AND WHEREAS**, the matter was placed in 310th Meeting held on August, 19-21 2019 of WRC and the Committee decided that. "The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"The Show Cause Notice was issued to the institution vide letter dated 21/12/2016 and reply received on 08/02/2017.

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 day as per the Show Cause Notice.

Moreover, the staff profile is not submitted in prescribed format. Percentage of Marks is not mentioned in staff profile. Building Completion Certificate, CLU & Building plan are not in original.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

8. **AND WHEREAS**, the Withdrawal order was issued to the institution on 28.08.2019.

9. **AND WHEREAS**, the institution filed an Appeal to the Council on 05.03.2020 and the Council vide its order dt. 15.09.2020 remanded back the case to the WRC, NCTE for necessary action.

10. **AND WHEREAS**, the matter was placed in 329th Meeting held on 17-19th February 2021, of WRC and the Committee decided "The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that that and noted the following:-

1. The institution is required to submit latest Staff list duly approved by the Registrar of the concerned affiliating body clearly indicating the seal and signature of the Registrar along with faculty approval letter issued by the concerned affiliating body.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 14 of the NCTE Act for B.Ed programme."

11. **AND WHEREAS**, the Final Show Cause Notice was issued to the institution on 11.03.2021, and its reply received on 15.03.2021.

12. **AND WHEREAS**, the matter was placed in 339th Meeting held on 28-30 July 2021 of WRC and the Committee decided that.

"This is a RPRO case and same was remanded back by the Appellate Authority.

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the Institution for B.Ed course with an annual intake of 100 students (Two units) be restored."

13. NOW THEREFORE, recognition dated 18.08.2008 and revised recognition order dt. 31.05.2015 issued to the institution viz **MAYARAM MAHAVIDYALAYA, RUN BY SWARGIYA BAIS MAYARAM SHIKSHA SAMITI, PLOT NO- 61/2, MEDHAULI - MORWA, SINGRAULI, SIDHI, MADHYA PRADESH** for B.Ed. course is hereby restored permitting the total annual intake of 100 (two unit of 50 students).
