ORDER

WHEREAS, the recognition was granted to the institution, namely, **MARATHAWADA ADHYAPAK MAHAVIDYALAYA, S.NO. 15, VILLAGE BRAHMAPURI, DIST. NANDED, MAHARASHTRA** for B.Ed. course vide Order No. WRC/5-6/APW07854/1231087/(Mino.Inst.)148th/2011/79274-79279 dated **23.06.2011** for an annual intake 100 seats.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No. WRC/APW07854/1231087/2015/143502,507,511,515,519,522,525,529 dated **31.05.2015** for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students) from the academic session 2015-2016.
3. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on **16.01.2017**.
4. **AND WHEREAS**, The matter was placed in 310th meeting of WRC held on August 19-21, 2019 WRC and the Committee observed as follows:-
"The Show Cause Notice was issued to the institution vide letter dated 16/01/2017. The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice.
Hence, the committee decided to **withdraw** the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."
5. **AND WHEREAS**, accordingly, Withdrawal Order was issued to the institution on 30.08.2019.
6. **AND WHEREAS**, The matter was placed in 315th meeting of WRC held on August 10-11 & 14, 2020 WRC and the Committee observed as follows:-
The WRC examined the documents submitted by the institution and observed the following deficiencies :-
 - Original staff list duly approved by the affiliating authority with stamp on each page as per NCTE Regulations 2014, as amended vide notification dated 09.06.2017 not submitted.
 - The Non Encumbrance Certificate is to be issued by Competent Revenue Authority.
 - Original FDRs for Rs. 12 lakhs towards Endowment and Reserve Fund not submitted.In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days w/s 17 of the NCTE Act."
7. **AND WHEREAS**, Accordingly, Final Show Cause Notice was issued to the institution on 02.09.2020. In response to the show cause notice, the institution has submitted replies vide letter dated 10.10.2022 received in WRC on 04.11.2022 & letter dated 10.10.2022 received in WRC on 10.11.2022.

8. **AND WHEREAS**, The matter was considered in 387th meeting of WRC held on 9-10 June, 2023 and the committee decided to withdraw recognition under section 17(1) of the NCTE Act. Accordingly, Withdrawal order was issued to the institution on 28.06.2023. Institution filed W.P. (c) 9730/2023 before the Hon'ble High Court of Delhi and vide order dated 08.08.2023 following directions were passed:

"7. I have considered the submissions made by learned counsel for the petitioner-institution and in view of the specific stand taken by the petitioner-institution in the instant writ petition with respect to compliance with the extant regulation and on consideration of the fact that all the reasons mentioned in the withdrawal order dated 28.06.2023 do not form part of either of the show cause notices.

8. Therefore, during the pendency of the appeal, the withdrawal order passed by WRC, dated 28.06.2023 deserves to be stayed.

9. It is, further directed that the petitioner-institution to deposit a sum of ₹10 lakhs by way of the demand draft in favour of WRC within 7 working days.

10. The Appellate Authority is to decide the appeal of the petitioner institution within four weeks from the date of filing of the appeal, without being influenced by any of the observations made in this order.

11. The petitioner-institution is allowed to participate in the counselling process for the Academic Year 2023-2024, subject to the final outcome of the instant writ petition."

9. **AND WHEREAS**, the matter was again considered by the WRC in its 393rd meeting held on 06th, September 2023 and Committee has decided the following:-

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

In compliance of order dated 8/8/2023 passed by the Hon'ble High Court of Delhi in the WP (C) No.9730/2023, the case was considered by the WRC and decides that during pendency of appeal the order dated 28/6/2023 passed by WRC is hereby stayed and the petitioner institution is allowed to participate in the counselling process for the academic session 2023-2024 for B.Ed course with annual intake of two units (100 seats) subject to final outcome of the instant writ petition. The order be issued accordingly. The institution is required to display the order on its website for information to all concerned.

NOW THEREFORE, the institution viz. MARATHAWADA ADHYAPAK MAHAVIDYALAYA, S.NO. 15, VILLAGE BRAHMAPURI, DIST. NANDED, MAHARASHTRA for conducting B.Ed. programme of two year duration with an annual intake of 100 students (Two units) is allowed to participate in the Counselling process for the academic year 2023-2024 subject to further order passed by the Court and outcome of the Instant writ petition. Therefore, the institution is required to display the order on its website for information to all concerned.
