WHEREAS, recognition was granted to the institution namely, Smt. Kashibai Navale College of Education, Savitribai Phule Society, Gat No. 273/2, Godasewadi, Kamlapur, Taluka Sangola, Dist. Solapur, Maharashtra. (WRC/APW00481/123064) under section 14 of NCTE Act. 1993 for conducting B.ED.course vide order dated 27.06.2005 for an annual intake of 100 students.

AND WHEREAS, the letter for submission of Affidavit regarding Acceptance and Compliance of NCTE Regulations, 2014 was issued to the institution submitted affidavit vide letter date 05.01.2015.

AND, WHEREAS, Revised recognition order was issued for two basic units of 50 students (50 students each) to the institution on 12.08.2015.

AND WHEREAS, the Show Cause Notice was issued to the institution on 17.03.2017 and reply submitted by the institution on 05.04.2017

AND WHEREAS, the matter was placed in 285<sup>th</sup> Meeting of WRC held on December 19-21, 2017 and the Committee decided that "The case file was seen. Show Cause Notice was issued to the institution on 17.03.2017. The institution has submitted a staff profile of 1+11 faculty members, which is not approved and not maintained additional FDR of Rs.4.00 lakhs (in joint name) (Total requirement is 12.00 lakhs).

Building Completion Certificate in the prescribed format and counter signed by a Govt. Engineer should be submitted in original.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

AND WHEREAS, clarification/conveying letter issued on 28.12.2017 and reply submitted by the institution on 09.01.2018

AND WHEREAS, the matter was placed in 287<sup>th</sup> Meeting of WRC held on January 30-31, 2018 and the Committee decided that "The case file was seen. In response to the Show Cause Notice dated 17.03,2017 and compliance letter dated 28.12.2017, the institution has not replied satisfactorily.

Hence, Recognition is withdrawn from the academic session 2018-2019."

AND WHEREAS, the Withdrawal Order issued on 06.02.2018. The institution filed an appeal to the appellate authority.

AND WHEREAS, the appeal order dated 13.08.2018, "the Committee concluded to remand back the case to WRC with a direction that appellant institution should get another opportunity to submit to WRC copy of list of faculty and Principal approved by affiliating university: b) BCC;c) NEC. Appellant is required to submit these documents to WRC within 15 days of the issue of appeal orders and WRC is directed to process the documents submitted for issue of revised orders on merits within 10 days of the appellant's submitting required documents as

Now THEREFORE, the Council hereby remands back the case of Smt. Kashibal Navale College of Education, Kamlapur, Godsewadl, Sangola Miraj Rond, Maharashtra to the WRC, NCTE, for necessary action as indicated above."

AND WHEREAS, the matter was placed in 297th Meeting held on September 13-14, 2018 of WRC and the Committee decided that "... The case file was seen. This is a case of appeal. The Appellate Authority vide order dated 13.08.2018 remanded the case to WRC to consider the documents submitted by the institution. The institution submitted the documents on 21.03.2018. The institution has submitted a staff profile of 1+7 faculty members, which is sufficient for one unit. Out of these, the faculty members at S. No. 7 & 8 are not approved, as the cases are under

AND WHEREAS, clarification/conveying letter issued on 19.09.2018 and reply submitted by the institution on 24.09.2018

AND WHEREAS, the matter was placed in 307th Meeting of WRC held on May 30-31, 2019 and the Committee decided that "... The original file of the Institution alongwith other related documents. NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following

The compliance letter was issued to the institution dated 19/09/2018 and the institution vide letter dated 24/09/2018 replied. The committee considered the reply of the institution and found in order.

Hence, the committee decided to restore the recognition for B.Ed. course (one unit 50 students)"

NOW THEREFORE, the recognition of Smt. Kashibal Navale College of Education, Savitribai Phule Society, Gat No. 273/2, Godasewadi, Kamlapur, Taluka Sangola, Dist. Solapur, Maharashtra for conducting B.Ed. programme of two years duration for one basic unit (50 students) is restored and is permitted to continue.
