ORDER

Whereas, recognition was granted to the institution, SMT. REWABEN ODHAVIJIBHAI PATEL WOMEN'S B.ED. COLLEGE, ITI CAMPUS, MORIBI, RAJKOT HIGHWAY, TANKARA, RAJKOT, GUJARAT-B.Ed. with for course an annual intake of 100 F.No.WRC/APW00500/323134/2015/140922/ dated. 31.05.2015.

And whereas, restoration order was issued to the institution vide order no. WRC/APW00500/323134/ B.E.d/ 304^{th} /GUJ/2019/202728 TO 202733 dt. 12.04.2019 reducing intake from 100 to 50 Students.

And whereas, the Institution vide letter dt. 24.02.2021 submitted an application for shifting of premises from SMT. REWABEN ODHAVIJIBHAI PATEL WOMEN'S B.ED. COLLEGE, ITI CAMPUS, MORIBI, RAJKOT HIGHWAY, TANKARA, RAJKOT, GUJARAT-363650 to Smt. Rewaben Odhavjibhai Patel Women's B.Ed. College, Behind new S.T. Stand, Patel Kanya Chhatralaya Campus -Morbi, Gujarat, Pin- 363641.

And whereas, the matter was placed before the WRC in its 321th meeting held on 09th to 11th NOVEMBER, 2021. The Committee decided as under:-

- 1. "Recognition was granted to the institution on 14.02.2005 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.
- 2. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Noted was issued to the institution on 28.09.2020.
- The institution has not submitted the reply of the Show Cause Notice till date.

In view of above, the Committee decided that the recognition of B.Ed programme of the institution be WITHDRAWN under clause 7(15) from the next academic session.

And whereas, thereafter, a withdrawal order No. WRC/NCTE/APW00500/323134/B.Ed./321st/2020/212892-212898 dt. 18.12.2020 was issued to the institution.

And whereas, thereafter, Institution had filed an appeal before the Appellate Authority at NCTE, New Delhi and the Appellate Authority vide order dt. 26.03.2021 decided as follows:

"After perusal of the Memorandum of appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC for revisiting the matter rafter locating the Demand Draft and documents submitted or alternatively seek copies of these document from the appellant institution.

Now therefore, The Council hereby remands back the case of Smt. Rewaben Odhavjibhai Patel Women's B.Ed. College, at Post - Tankara, Morbi - Rajkot Highway, Rajkot, Gujarat to the WRC, NCTE, for necessary action as indicated above."

And whereas, institution made application for shifting of premises on 19.11.2020 & 07.07.2021 along with relevant documents.

And whereas, the matter was placed before the WRC in its 344th meeting held on 13TH, OCTOBER, 2021 and it was decided:
