ORDER

WHEREAS, the institution, namely, SMT. MANIBA MAHILA B.ED. COLLEGE, AT. POST. VAHELAL TA. DASCROI, AHMEDABAD-382350, GUJARAT was granted recognition for B.Ed. Course of one year duration with an annual intake of 100 students vide order No. WRC/2-32/323133/71/2005/3599 dated 23.04.2005 and affiliating body being SNDT Women's University.

- 2. AND WHEREAS, permission was granted by WRC in its 209th meeting for change of affiliating body of the institution from SNDT Women's University to Gujarat University vide order dated 05.09.2014.

AND WHEREAS, request received vide letters dated 29.10.2021, 09.12.2021, 17.10.2021 followed by E-mail dated 12.12.2022 from the Registrar, Monark University attaching therein a copy of Gujarat Private Universities (Amendment) Act, 2021 regarding the establishment of Monark University published in The Gujarat Government Gazette Extraordinary vide Notification dated 22.05.2021. In the letter, it is mentioned that after the establishment of Monark University, following institutions have become the constituent institutions of Monark University from the academic year 2021-2022:-

  - 3. 325065: MANUGUBA M.ED. COLLEGE, MONARK EDUCATION TRUST, AT POST- VAHELAL, TA. DASKRIO, DIST. AHEMDABAD, GUJARAT-382330, AHEMDABAD, GUJARAT-382330 (M.Ed. course)
- 5. AND WHEREAS, the matter in respect of aforesaid three institutions run by the same trust was considered by WRC in its 378th meeting held on 21st & 22nd December, 2022 and the Committee decided as follows:-

"The original files of the Institution along with other related documents was carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Recognition was granted for B.Ed. and M.Ed. course with affiliating/examining body as Gujarat University.
- Request made vide letters dated 29.10.2021, 09.12.2021, 17.10.2021 followed by E-mail received dated 12.12.2022 by the Registrar, Monark University attaching therein a copy of Gujarat Private Universities (Amendment) Act, 2021 regarding the establishment of Monark University published in The Gujarat Government Gazette Extraordinary vide Notification dated 22.05.2021.

- A notarized English translated copy of Notification dated 06.08.2021 issued by Gujarat University regarding the de-affiliation of 11 colleges sponsored by Shree Monark Education Trust, Vahelal, Ahmedabad from the academic year 2021-2022 in reference to a resolution passed vide letter dated 18.07.2021 by President, Monark University and letter dated 02.08.2021 by Registrar, Monark University attached.
- A copy of Notification dated 02.06.2021 issued by Education Department, Govt. of Gujarat related to The Gujarat Private Universities (Amendment) Act, 2021 is submitted.
