RECOGNITION ORDER

- The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009.
- The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
