#### RECOGNITION ORDER

JABALPUR-482001, MADHYA PRADESH (APW04306/222230) had submitted on 26.12.2006 the application to the Western Regional Committee of the NCTE for grant of recognition for starting the D.Ed. NOW THEREFORE, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to CE\_TRE FOR HIGHER STUDIES ELEMENTARY TEACHER EDUCATION D.Ed. COLLEGE, PLOT NO.89/11, 89/12 PC NO.48/51, NEEMKHEDA GOUR TIRAHA MANDLA ROAD, STREET NO.210, VILLAGE /TOWN: SALIWADA, TEH/DISTT. JABALPUR-482001, MADHYA PRADESH for starting the D.Ed. Course of 2 Year with an annual intake of 50 (Fifty) seats from the academic session 2012-2013.
- 4. Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations, 2009.
- 5. The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its inability to do so.
- 6. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009.
- 7. The institution shall ensure that the required number of acader c staff for conducting the course is always in position.
- 8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
