RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to **SHIVAJI SHIKSHAN PRASARAK MANDAL, TAKLI (P.D) TAL. CHALISGAON, AT & PO TAKALI (P.D), JALGAON-424101, MAHARASHTRA**, under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/2-32/123097/76/2005/6301 dt. 09.08.2005.

AND WHEREAS, Revised Recognition order was issued to **SHIVAJI SHIKSHAN PRASARAK MANDAL,, TAKLI (P.D) TAL. CHALISGAON, AT & PO TAKALI (P.D), JALGAON-424101, MAHARASHTRA**, vide order No. F.No. WRC/APW00763/123097/2015/143880- 143902 dated 31-05-2015 for B.Ed. of Two Years Duration with an annual intake of 100 students (Two basic unit of 50 students) from the academic session 2015-2016.

AND WHEREAS, the matter was placed in 316th Meeting held on August 27-28, & 04 September 2020 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made:

"...The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision."

AND WHEREAS, the Show Cause Notice was issued to the institution on 30.09.2020 as per decision of WRC, and its reply received from the institution on 28.10.2020.

AND WHEREAS, the matter was placed in 321st Meeting held on November 09-11, 2020 of WRC and the Committee decided that:-

"...The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. Recognition was granted to the institution on 09.08.2005 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.
2. The institution has not shifted the institution in its own premises till date.
3. Accordingly, Show Cause Notice was issued to the institution on 30.09.2020.
4. The institution has not submitted the reply of the Show Cause Notice till date.

In view of above, the Committee decided that the recognition of B.Ed programme of the institution be WITHDRAWN under clause 7(15) from the next academic session 2021-21"

AND WHEREAS, the Withdrawal order was issued to the institution on 19-12-2020.

AND WHEREAS, the institution filed an appeal against the withdrawal order dt. 19.12.2020 the appellate authority has passed an order dt. 12.03.2021 and remands back the case. And its reply received in WRC on 25.03.2021.

AND WHEREAS, the matter was placed in 339th Meeting held on July 28-30, 2021 of WRC and the Committee decided that:-

"... This is a RPRO case and same was remanded back by the Appellate Authority.

The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation were made:

The institution has not submitted the following documents :-

1. Translated version of land documents duly notarized.
2. Non Encumbrance Certificate issued by the Competent Authority
3. Fire Safety Certificate issued by the Competent Authority
4. Building Safety Certificate issued by the Competent Authority
5. Building Disabled Friendly Certificate issued by the Competent Authority
6. Land Possession / Mutation Certificate issued by the Competent Authority
7. Staff list duly approved by the affiliating body for the staff presently working in the institution.
8. Building plan duly approved by the Competent authority for the existing course.
9. Fixed Deposit receipt in original for Rs. 5 lacs and 7 lacs towards Endowment and Reserve fund.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act for B.Ed. programme."


AND WHEREAS, the Show Cause Notice was issued to the institution on 14.08.2021 its reply received in WRC on 09.09.2021 & 30.09.2021.

AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 14035/2021 CM APPL. 44315/2021 dt. 09.12.2021 the operative part is produced here below:-

"...The petitions are, therefore, allowed, and NCTE is directed to issue orders of restoration of recognition to the petitioners. The petitioners will be permitted to participate in counselling and admit students for the year 2021-22 and for subsequent years, until and unless fresh withdrawal orders are passed against them. The status of the petitioners as recognised institutions will also be reflected on the NCTE's website, and will be communicated by the NCTE to the petitioners' affiliating university as well as to the concerned State Government. The NCTE is directed to comply with these directions within one week."

NOW THEREFORE, recognition dated 09.08.2005 and revised recognition order dt. 31.05.2015 issued to the institution viz **SHIVAJI SHIKSHAN PRASARAK MANDAL, TAKLI (P.D) TAL. CHALISGAON, AT & PO TAKALI (P.D), JALGAON-424101, MAHARASHTRA** for B.Ed. course with an annual intake of 100 students (two basic units of 50 students) is hereby restored.
