RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely **LATE NIRDHANRAO PATIL WAGHAYHE ADHYAPAK MAHAVIDYALAYA, ATL LAKHANI, TAH, LAKHANI DIST-BHANDARA MAHARASHTRA - 441804** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/2-32/123257/74/2005/5079 dated 27.06.2005.

AND WHEREAS, Revised Recognition order was issued to **LATE NIRDHANRAO PATIL WAGHAYHE ADHYAPAK MAHAVIDYALAYA, ATL LAKHANI, TAH, LAKHANI DIST-BHANDARA MAHARASHTRA - 441804** vide order No. WRC/APW01806/123257/2015/151620-1627 dated 21.08.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic unit of (50 students each) from the academic session 2015-2016.

AND WHEREAS, Compliance was not submitted as per regulations 2014.

AND WHEREAS, the matter was placed in 316th Meeting of WRC held on 27th, 28th August 2020 and 4th September 2020 and the Committee decided that

"...The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision."

AND WHEREAS, a Show Cause notice was issued to the institution on 06.10.2020.

AND WHEREAS, the reply of show cause notice was not submitted by the institution.

AND WHEREAS, the matter was placed in 322nd meeting of WRC held on 23rd - 24th November, 2020 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. Recognition was granted to the institution on 27.06.2005 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.
2. The institution has not shifted the institution in its own premises till date.
3. Accordingly, Show Cause Notice was issued to the institution on 06.10.2020.
4. The institution has not submitted the reply of the Show Cause Notice till date.

In view of above, the Committee decided that the recognition of B.Ed programme of the institution be WITHDRAWN under section 17 (3) of the NCTE Act from the next academic session 2021-22.

AND WHEREAS, the Withdrawal order was issued to the institution on 20-12-2020.

AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 14107/2021 dt. 10.12.2021 the operative part is produced here below:-

"...In view of the above, there is no impediment to the petitioner participating in the counselling, and admitting students for the academic session 2021-2022. The NCTE is directed to reflect the status of the petitioner as a recognised institution for the year 2021-22 on its website. The NCTE is also directed to communicate the same to the petitioner's affiliating university, and the concerned State Government within one week from today.

The Appellate Committee of the NCTE may also endeavour to dispose of the petitioner's appeal as expeditiously as possible and practicable, and will in any event do so not later than 03.03.2020."

NOW THEREFORE, recognition of the institution viz LATE NIRDHANRAO PATIL WAGHAYHE ADHYAPAK MAHAVIDYALAYA, ATL LAKHANI, TAH, LAKHANI DIST-BHANDARA MAHARASHTRA - 441804 for B.Ed. course with an annual intake of 100 students (Two unit) is hereby restored for the session 2021-2022.
