

Whereas, recognition was granted to the institution, **ANAND SHIKSHAK PRASHIKSHAN MAHAVIDYALAYA, PUROHIT BHAWAN, SINEMA GALI, SAWAI MADHOPUR, RAJASTHAN** for B.ED course with an annual intake of 100 students vide order no. F.NRC/NCTE/F-7/6863-6878 dt. 13.08.2006.

And Whereas, Revised Recognition order was issued to **ANAND SHIKSHAK PRASHIKSHAN MAHAVIDYALAYA, PUROHIT BHAWAN, CINEMA GALI, SAWAI MADHOPUR, RAJASTHAN** vide order no. F.No. WRC/NRC/NCTE/F-7/RJ-619/2015/105185-90 dated 26.05.2015 for B.Ed. of Two Year Duration with an annual intake of 100 students (Two basic unit of 50 students each) from the academic session 2015-2016.

And Whereas, the Institution vide letter dt. 14.09.2015 submitted an application for shifting of premises from **ANAND SHIKSHAK PRASHIKSHAN MAHAVIDYALAYA, PUROHIT BHAWAN, SINEMA GALI, SAWAI MADHOPUR, RAJASTHAN** to **Anand Shikshak Prashikshan Mahavidyalaya, Plot NO. 5190, Street No. Isarda Road, Post Office- Shivad, Tehsil/Taluka – Chhoth ka BarwaraDist – Sawai Madhopur, Rajasthan - 322001.**

And Whereas, The matter was placed before the WRC in its 245<sup>th</sup> meeting held on 24<sup>th</sup> to 27<sup>th</sup> November, 2015. The Committee decided as under:-

*"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made.*

- The institution has submitted the CLU for the land area of 1400 sqm which is much less than that the minimum the required land area for B.Ed. as per NCTE Regulations 2014.
- Building plan submitted by the institution does not have khasra No. / Plot No.

Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice."

And Whereas, the matter was placed before the WRC in its 332<sup>nd</sup> meeting held on 1<sup>st</sup> to 2<sup>nd</sup> March, 2020. The Committee decided as under:-

*"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-*

**VT of the institution be constituted for shifting of premises."**

And Whereas, the matter was placed before the WRC in its 347<sup>th</sup> meeting held on 3<sup>rd</sup> to 5<sup>th</sup> December, 2021. The Committee decided as under:-

"This is a case of shifting of premises.

Committee considered the V.T. report for shifting, original file of the Institution along-with other related documents were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The institution has complied with all the requirements as per NCTE Regulations and WRC decided to permit the shifting from old premises **Anand Shikshak Prashikshan Mahavidyalaya, purohit Bhawan Cinema Gali, Sawai Madhopur** to new premises **Anand Shikshak Prashikshan**
