Withdrawal Order U/S-17

WHEREAS, recognition was granted to the institution, namely, BHOPAL DEGREE COLLEGE, 393, ASHOK VIHAR, ASHOKA GARDEN, DISTRICT.- BHOPAL,- 462023, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting **B.ED.** course vide order dated 07.07.2003, 09.07.2004 & 12.05.2012.

AND WHEREAS, One Shri Pawan Dubey filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since the institutions are existing institutions, the inspection was conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 17.11.2014.

AND WHEREAS, the Deficiency Letter was issued by the NCTE Hqrs. to the institution on 06-05-2015 and the institution was submitted reply on 12-06-2015 in WRC forwarded to Hqrs for necessary action.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 05-02-2015.

AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on **31.05.2015**.

AND WHEREAS, the VTR alongwith file of the institution were received from NCTE Hqrs. in WRO on 12.11.2015.

AND WHEREAS, the matter was placed in 239th Meeting of WRC held on January 06-08, 2016 and the Committee decided that "...Hence, Show Cause Notice u/s 17 be issued on the above grounds."

AND, WHEREAS, Show Cause Notice was issued to the institution on 01.02.2016 and the reply was received on.02.03.2016.

AND WHFREAS, the matter was placed before the WRC in its 246th meeting held on March 16-18, 2016 and the Committee decided that "... Consequent to the consideration of the reply of the institution, to the points raised after inspection under Section 13, the WRC had issued a Show Cause Notice on 01/02/2016. The institution vide reply dt. 02/03/2016 has given the following responses:

- 1) The two lists of faculty submitted by the institution are unapproved by the affiliating University. Further, the institution should appoint staft as per the NOTE Regulations, 2014 i.e. 16 faculty members for two units of the B.Ed. course.
- ii) As against the requirement of 3500 sq. mtrs built up area, the institute has submitted a map wherein the built up area is shown as 1794 so mtrs. Building Completion Certificate has not been submitted.

Hence, Clarification be obtained on the above grounds."

AND WHEREAS, letter for Clarification was issued to the institution on 21.03.2016 and the reply was received on 12.04.2016.

AND, WHEREAS, Application received dt. 02.04.2016 for change of Premises for B.Ed. and D.Ed. course with depositing the process fee of Rs. 1.50 lakhs, alongwith supporting documents.

AND WHEREAS, the matter was placed before the WRC in its 252nd meeting held on May 09-10, 2016 and the Committee decided that ".... Clarificatory letter was issued on 21/03/2016 and the institution replied on 12/04/2016. The points are as under :-

- i) The two lists of faculty members are not approved by the affiliating University. Further, it must appoint 16 faculty members for two units of the B.Ed. course. In reply, the institution has submitted a list of 11 faculty members approved by the affiliating University for one unit of the B.Ed. course.
- ii) As against the requirement of 3500 sq. mtrs. of built up area, the institution has only 1794 sq. mtrs. and the Building Completion Certificate has not been submitted. The institution has stated in their reply that they have applied for shifting and they have the required built up area in the new premises.

No further action is required in this case and the application for shifting be processed."

AND, WHEREAS, No further action letter was issued to the institution on 20.05.2016.

The minutes of 252nd meeting were confirmed by the Committee with the following amendments. The decisions be read as follows:

 At the Serial No 34 in Case No. APW00025/223110:- "Hence, Show Cause Notice be issued on the above grounds for processing of the shifting of premises."

AND, WHEREAS, Show Cause Notice was issued to the institution on 21.06.2016 and the reply was received on.20.07.2016.

AND WHEREAS, the matter was placed before the WRC in its **282nd meeting held on October 24-26**, **2017** and the Committee decided that ".... This is a case of shifting. An examination of the file shows that the institution has not submitted the latest CLU with premium receipt, FDRs and the latest staff list approved by the competent authority.

Hence, Show Cause Notice be issued on the above points. Reply should be submitted within one month."

AND, WHEREAS, Show Cause Notice was issued to the institution on 30.10.2017 and reply was received on.30.11.2017.

AND WHEREAS, the matter was placed before the WRC in its **285th meeting held on December 19-21, 2017** and the Committee decided that ".... Show Cause Notice was issued to the institution on 30.10.2017 and reply received on 30.11.2017. The institution has submitted CLU premium receipt, FDRs and latest staff list. However, it is seen that the diverted land is much less than the required 3000 sq.mts. for running one unit of B.Ed. and one unit of D.Ed. course.

Compliance should be submitted by the institution within one month.

As requested by the management, the intake for the B.Ed. course is reduced to one unit from two units."

AND WHEREAS, Reduced intake order was issued to the institution on **01.01.2018** for the intake of 100 students (2 basic units) to 50 students (one unit.)

AND, WHEREAS, letter for Clarification was issued to the institution on 29.12.2017 and the reply was received on 30.01.2018.
