WITHDRAWAL ORDER

WHEREAS, WRC, NCTE had granted recognition/ permission to the institution namely T.D.D.ED. COLLEGE, 11/415, INDIRA NAGAR, UNIVERSITY ROAD, REWA-486001, MADHYA PRADESH vide order no. WRC/S-6/90/2006/dt. 30.10.2006 for conducting the D.Ed. course one-year duration with an annual intake of 50 students (one basic Units).

AND WHEREAS, the matter was placed in 316" Meeting held on 27th -28th, August & 04th September 2020 and WRC Committee decided that". The WRC considered the entire issue in detail and noted that as per NCTF Regulations dated 13.11.2002. Initially institutions were permitted to start the course in rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted of their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have no yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have apply d for shifting of premises be examined by office at the earliest and placed before W for consideration and decision."

AND WHEREAS, the Show Cause Notice was issued to the institution on 23.09.2016 and replywas including the stipulated time of 30 day as per the show Cause Notice.

AND WHEREAS, the Matter was considered by WRC in its 322nd Meeting held on 23 and November 2020 and WRC decided (Ref. Sl. No. 92, Page No. 82-83 of 322nd WRC Minutes) as under a supplier of the second of the

The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations of Guidelines issued by NCTE from time to time and the following observation was not de the

- Recognition was granted to the institution on 05 01 2008 on rented premises with a content that to shift the institution in its own premises within a period of three years from the disconsissue of recognition order.
- 2 The institution has not shifted the institution in its own premises till date.
- 3 Accordingly, Show Cause Notice was issued to the institution on 23.09.2020.
- 4 The Institution has not submitted the reply of the Show Cause Notice till date.

In view of above, the Committee decided that the recognition of D.EL.Ed programm of the institution be WITHDRAWN under section 17 (3) of the NCTE Act from the lext a demic session 2021-22."
