RESTORATION ORDER

WHEREAS the recognition was granted to the institution namely KESHARI SHIKSHAN SAMITI, PLOT NO.3428, MAIN ROAD, VILLAGE -KHOKHARA, TEHSIL- JANJGIR, DISTRICT-CHAMPA, CHHATISGARH for B.Ed. course vide Order No. WRC/WRCAPP920/153rd/B.ED./2011/81003-81009 dt. 30.08.2011.

- 2. AND WHEREAS, the revised order was issued to the institution namely **KESHARI SHIKSHAN SAMITI**, **PLOT NO.3428**, **MAIN ROAD**, **VILLAGE -KHOKHARA**, **TEHSIL- JANJGIR**, **DISTRICT-CHAMPA**, **CHHATISGARH** vide Order no. WRC/APP920/2015/139406-413 dt. 31.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.
- 3. AND WHEREAS, Vide letter dt. 28.10.2015 received in WRC on 28.10.2015, the institution has submitted compliance of Revised Recognition Order.
- 4. AND WHEREAS, a Show Cause Notice was issued to the institution on 25.09.2017 and the institution has submitted its reply dt. 18.10.2017 received in WRC on 23.10.2017.
- 5. AND WHEREAS, the matter was placed in 293rd meeting of the WRC held on June 12-14, 2018 and the Committee observed as follows:-
- "...The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 25.09.2017 was issued and the institute replied on 18.10.2017.

Institute has submitted the staff profile of (1+15) approved by the Registrar. Building Completion Certificate from a Govt. Engineer is not submitted.

Hence, Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn.

- 6. AND WHEREAS, a letter was issued to the institution on 22.06.2018.
- 7. AND WHEREAS, vide letter dt. 28.06.2018 received in WRC on 09.07.2018 the institution has submitted the documents.
- 8. AND WHEREAS, the matter was placed in 366th meeting of the WRC held on 12th and 14th July, 2022 and the Committee observed as follows:-
- "...The original file of the Institution, Visiting Team Report along-with other related documents were carefully examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

First SHOW CAUSE NOTICE was issued on 20.11.2017. and a letter on 5.Jan 2018.

- The institution has not submitted the Building Completion Certificate in prescribed format in original issued by competent Government Authority indicating the total built up area, total land area and khasra No.
- The institution has not uploaded the necessary information on its official website.
- The institution has also not submitted the filled copy of the Performance Appraisal Report.

In view of the above, the Committee decided to withdraw the recognition of B.Ed. programme U/S 17 of the NCTE Act 1993, with effect from the end of the academic session next following the date of communication of the said order."

- 9. AND WHEREAS, Withdrawal Order was issued to the institution on 04.10.2022.
- 10. AND WHEREAS, the institution preferred an appeal against the withdrawal order dt. 04.10.2022 and the appellate authority has passed an order dt. 21.12.2022 and remands back the case decided as follows:-

"...Noting the submission and verbal arguments advanced during the hearing, Appeal Committee decided to remand back the case to WRC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action a per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the WRC the documents submitted in appeal with 15 days from the receipt of order of the Appeal. The WRC is at a liberty to verify the submitted documents from the concerned issuing authority.

DECISION

After perusal of the Memorandum of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to WRC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the WRC the documents submitted in appeal with 15 days from the receipt of order of the Appeal. The WRC is at a liberty to verity the submitted documents from the concerned issuing authority.

- 11. Vide letter dt. 23.12.2022 received in WRC on 14.02.2023 the institution has submitted the requisite documents as directed by the Appellate Authority.
- 12. AND WHEREAS, the matter was considered by the WRC in its 387th meeting held on 9th & 10th June, 2023 and the Committee decided as under:

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and in continuation of decision recorded in the minutes of 366TH meeting of WRC held on 12th & 14^{th July}, 2022, the Committee observed as under:

- i. As per decision in 366th meeting, withdrawal order was issued to the institution on 04.10.2022.
 - ii. The institution filed an appeal against the withdrawal order dt. 04.10.2022 and the appellate authority has passed an order dt. 21.12.2022 and remanded back the case to WRC.

iii. Vide letter dt. 23.12.2022 received in WRC on 14.02.2023, the institution has submitted the reply in response to appeal.

In view of the above, the Committee decided that restoration order be issued to the institution with a copy endorsed to State Govt., Affiliating Body and others concerned. A copy of restoration order be uploaded on the NCTE web portal.

- 13. NOW THEREFORE, recognition of the institution viz KESHARI SHIKSHAN SAMITI, PLOT NO.3428, MAIN ROAD, VILL-KHOKHARA, THE- JANJGIR, DIST-CHAMPA, CHHATISGARH for conducting B.Ed. programme of two years duration with an annual intake of 100 students (Two units) is hereby restored.
- 14. The terms and conditions shall remain same as mentioned in the revised recognition order issued vide order dt. 31.05.2015.
