CONTINUATION ORDER

WHEREAS, recognition was granted to the institution namely, **JAIN COLLEGE OF EDUCATION MHOW-NEEMACH ROAD, MANDAU 458002, MADHYA PRADESH** under section 14(1) of the NCTE Act, 1993 for conducting **B.ED.(CO.ED)** course of one year duration with an annual intake of 100 (**SEC**) (two basic Units of 50 students each) vide order No. WRC/2-32/59/213033/2004/3096 to 97 dated 19.05.2004.

2. AND WHEREAS, the revised recognition order was issued to **JAIN COLLEGE OF EDUCATION MHOW-NEEMACH ROAD, MANDAU 458002, MADHYA PRADESH** vide order No. WRC/AP/00271/213033/2015/149004-9012 dt. 31.05.2015 for B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided "...issued Show Cause Notice to the institution of the condition maintained in revised order"

4. AND WHEREAS, a Show cause notice was issued to the institution on 26.07.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order.

- 1) Staff Profile for the session 2015-2016 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

5. AND WHEREAS, the matter was placed in 301st Meeting held on April 15-16, 2019 and the Committee decided that "... The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 26.07.2016 was issued.

The institution in its reply dated 09.08.2016 & 20.08.2016 has submitted a photocopy of staff list from S.No.1 to 15 and from S.No.16 to 19 not approved by the Registrar. Building Completion Certificate and remaining FDRs for Rs.8.00 lakhs are also not submitted.

The institution should submitted latest staff profile approved by the competent authority in original as per Appendix-IV of NCTE Regulations, 2014 and amended notification published on 09.06.2017 (in the prescribed proforma) and Building Completion Certificate issued by the competent authority and remaining FDRs for Rs.8.00 lakhs in joint name.

Hence, Compliance should be submitted by the institution within one month.

6. AND WHEREAS, the clarification letter was issued to the institution on 24.01.2019 and reply was submitted by the institution on 06.02.2019.

7. **AND WHEREAS**, the matter was placed in 310th meeting of WRC held on August 19-21, 2019 and the Committee decided as under:-

The compliance letter was issued to the institution vide letter dated 24/01/2019 and reply received on 06/02/2019.

On perusal of the reply of the institution the committee observed that:

- The institution has submitted scanned copy of staff profile of 1+15.
- The staff at Sr. 7, 9 & 11 are not qualified as per NCTE Amended Regulations 9/6/2017.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.

8. **AND WHEREAS**, the Withdrawal order was issued to the institution on 05.09.2019.

9. **AND WHEREAS**, the institution has filed an appeal to NCTE, Hqrs on 26.10.2019, "The Appellate Authority vide its appealed order dat. 17.02.2020 remand back the case to the WRC, NCTE for necessary action.

10. **AND WHEREAS**, the matter was placed in 315th Meeting held on July 27th to 28th, September 2020 and the Committee decided as under:-

The Committee considered the matter in view of the order of the Appellate Authority, Agenda Note and observed the following:-

The staff at Sr. No. 09 in the staff list is not qualified as per NCTE Regulations, as amended vide notification dated 09.06.2017.

In view of the above, the Committee decided that last opportunity be given to the institution to submit its representation within 30 days u/s 17 of the NCTE Act for B.Ed course.

11. **AND WHEREAS**, Accordingly, a Show Cause Notice was issued on 21.09.2020 and the institution has submitted reply received on 22.09.2020.


12. **AND WHEREAS**, the matter was placed in 336th Meeting held on July 24th to 25th, March 2021 and the Committee decided as under:-

The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

*On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution **JAIN COLLEGE OF EDUCATION MHOW - NEEMACH ROAD, MANDSAUR 458002, MADHYA PRADESH** for B.Ed programme for 2 basic units of 50 students in each unit.*
