## WITHDRAWAL ORDER

WHEREAS, the institution, namely, **SWAMI NARAYAN GURUKUL TRUST, SHREE MUKESH JANI B.ED COLLEGE, JESHINGPARA, GAVDAKA ROAD, TA & DIST. AMRELI, GUJARAT** was granted recognition by WRC NCTE for B.Ed. Course vide order No.WRC/5-6/102nd/2008/30412-30417 dated **13.08.2008.** 

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No.WRC/APW04203/323412/2015/140930-937 dated **31.05.2015** for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.
- 3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255<sup>th</sup> WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on **26.08.2016**.
- 4. AND WHEREAS, in response to the aforesaid show cause notice, reply not submitted by the institution.
- 5. AND WHEREAS, the matter was placed in the 312<sup>th</sup> meeting held on January 27-29, 2020 and the Committee has decided the following:-

"On careful perusal of the file of the institution and other related documents, the Committee observed as under:-

- Revised recognition order was issued to the institution on 31.05.2015 with certain conditions. The compliance to the Revised recognition order was not received.
- The Show Cause Notice dated 26.08.2016 was issued to the institution on account of non compliance to the revised recognition order.
- No reply / required documents have been received from the institution.

The Committee resolved to give last opportunity to the institution to submit compliance to the Revised Recognition Order as per NCTE Regulations 2014, as amended vide Notification dated 09<sup>th</sup> June 2017 within 30 days."

- 6. AND WHEREAS, Show Cause Notice was issued to the institution on 10.02.2020.
- 7. AND WHEREAS, in response to the aforesaid show cause notice, reply submitted by the institution vide letter dated 09.03.2020 received in WRC on 16.03.2020.
- 8. AND WHEREAS, the matter was placed in the WRC in its 374<sup>th</sup> meeting (PART-1) held on October 18-19, 2022 and the Committee decided as under:-

"The original file of the Institution along-with other related documents, representation dated 09.03.2020 in response to show cause notice dated 10.02.2020 for compliance of deficiencies were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Show cause notice dated 26.08.2016 was issued to the institution due to non-compliance of conditions mentioned in the revised recognition order dated 31.05.2015.
- No reply/ required documents have been received from the institution.
- The matter was placed before the WRC in its 312<sup>th</sup> meeting held on 27-29 January, 2020 and accordingly, second show cause noticed dated 10.02.2020 was issued to the institution.
- The reply vide letter dated 09.03.2020 submitted by the institution was considered by WRC

The institution is still deficient on the following in light of NCTE Regulations, 2014 and subsequent amendments published time to time:

- Certified copy of registered land documents not submitted.
- The notarized Change of Land Use Certificate dated 16.04.2002 issued by Mamlatdar, Amreli shows that the land is owned by Shri Atulbhai Bhaichandra Jani & Shri Visvashbhai Bhaichandra Jani. The diverted area not mentioned in the CLU.
- Photocopy of submitted Building plan approved by Amreli Municipal Corporation, wherein the name of owner mentioned Shri Atulbhai Bhaichandra Jani & Shri Visvashbhai Bhaichandra Jani. Survey/khasra no. not mentioned. Total plot area, built up area mentioned is not legible.
- In the submitted Building completion certificate, name of owner mentioned Shri Atulbhai Bhaichandra Jani & Shri Visvashbhai Bhaichandra Jani. Built up area mentioned as 2525 sq.ft. which is not as per NCTE Norms.
- Faculty in Performing Arts (Music/Dance/Theatre) not appointed.
- Experience certificate of Principal substantiating eight years of teaching experience in a Secondary Teacher Education Institution as per NCTE Regulations, 2014 not submitted.
- Photocopy of FDR for Rs.4.00 lakh submitted is not in joint operation mode with Regional Director, WRC,NCTE.
- Non-encumbrance certificate is not submitted.

In view of the above, the Committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

12. **NOW THEREFORE**, recognition granted to the institution, namely, **SWAMI NARAYAN GURUKUL TRUST**, **SHREE MUKESH JANI B.ED COLLEGE**, **JESHINGPARA**, **GAVDAKA ROAD**, **TA & DIST. AMRELI**, **GUJARAT** for B.Ed. course (Code No.APW04203/323412) for an annual intake of 100 students (two basic unit of 50 students each) is hereby withdrawn under section 17 of the NCTE Act 1993 with effect from the end of the academic session next following the date of the communication of the said order.

Further, if the institution is not satisfied by the order, it may prefer an appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through 'online mode' available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
