WITHDRAWAL ORDER

WHEREAS, the institution, namely, NARAYANRAO PATIL WASADE COLLEGE OF PHYSICAL EDUCATION, CIVIL LINES, TA. CHANDRAPUR, DIST. CHANDRAPUR-442401, MAHARASHTRA was granted recognition by WRC NCTE for B.P.Ed. Course with an annual intake of 50 students vide order No.WRC/2-32/49/2003/3150-52 dated 07.07.2003.

- 2. AND WHEREAS, formal recognition order was issued to the institution vide order No. F.WRC/5-6/48/2003/4661-66 dated 04.11.2003.
- 3. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No.WRC/APW00181/124011/2015/152553-560 dated **10.09.2015** for conducting B.P.Ed. programme of two years duration with an annual intake of 100 students (one basic units of 100 students each) from the academic session 2015-16.
- 4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on 30.09.2016.
- 5. AND WHEREAS, the reply submitted by the institution vide letter dated 17.10.2016.
- 6. AND WHEREAS, the matter was considered by the WRC in its 281st meeting held on September 19-20, 2017 and the Committee decided as under:-

"In order to systemetise the compilation of complete information of all TEPs in the country, the NCTE HQrs New Delhi had asked all institutions to submit the Mandatory Affidavit on the prescribed format. The first such Public Notice was issued on 05.10.2016. Further opportunity was given on 16.06.2017, and the last date for submission was 12.09.2017.

NCTE Delhi also issued Show Cause Notice through PUBLIC NOTICE to submit the Mandatory Affidavit within the specified date. Then, it compiled the list of institutions and identified TEIs which had not complied with the submission of Mandatory Affidavit. The lists were sent to the WRO to reconcile the discrepancies with regard to the address as well as duplication of entries for placing the list to WRC for initiating the process of de-recognition of such institutions. These lists were tabled during the meeting.

The WRC perused the lists as provided by the HQrs as well as the details provided by the WRO.

Thereafter, the WRC decided to issue Show Cause Notice u/s 17 of the NCTE Act for non-compliance of the directions of the NCTE, and why the institution should not be derecognized. The reply should be sent on or before 23rd October 2017 after which further necessary action will be taken as per the Regulations."

 AND WHEREAS, show cause notice was issued to the institution on 06.10.2017. In response, the institution has not submitted any reply.

8. AND WHEREAS, the matter was considered by the WRC in its 366th meeting held on July 12-14, 2022 and the Committee decided as under:-

"The original file of the Institution, Visiting Team Report along-with other related documents were carefully examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-

- Final Show Cause Notice issued on 06.10.2017. Reply not received within stipulated time.
- Hence Committee decided to withdraw the recognition of the B.P.Ed. Course.
- The institution has not uploaded the necessary information on its official website.
- The institution has also not submitted the filled copy of the Performance Appraisal Report.

In view of the above, the Committee decided to withdraw the recognition of B.P.Ed programme U/S 17 of the NCTE Act 1993, with effect from the end of the academic session next following the date of communication of the said order."

9. **NOW THEREFORE,** recognition granted to the institution, namely, **Narayanrao Patil Wasade College Of Physical Education, Civil Lines, Chandrapur, Dist-Chandrapur-442401, Maharashtra** for B.P.Ed. course (Code No.APW00181/124011) for an annual intake of 100 students (one basic unit of 100 students each) is hereby withdrawn under section 17 of the NCTE Act 1993 with effect from the end of the academic session next following the date of the communication of the said order.

Further, if the institution is not satisfied by the order, it may prefer an appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through 'online mode' available on NCTE's website www.ncte-india.org within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
