WITHDRAWAL ORDER

WHEREAS, the institution, namely, **APEX EDUCATION TRUST SANCHALIT B.ED COLLEGE, RAVAPUR-GHUNDA ROAD, ROYAL AVENUE SOCIETY, LAJAI TA. TANKARA, DIST. RAJKOT, GUJARAT** was granted recognition by WRC NCTE for B.Ed. Course with an annual intake of 100 students vide order No.WRC/5-6/98th/2007/C-18236-18243 dated **26.06.2007**.

2. AND WHEREAS, WRC on the direction of the NCTE headquarters vide letter No.49-8/2008/NCTE(N&S)/78627 dated 21.05.2008 from NCTE, New Delhi directing WRC to conduct the inspection of 129 colleges of Gujarat u/s 17 of NCTE Act 1993, as per the observation of Prin. A.U. Patel, the Chairman, fee/Admission Committee for self-finance B.Ed./B.P.ED. course, Gujarat State & Formal Vice Chancellor, Gujarat University. The Western Regional Committee had constituted a Visiting Team u/s 17 of the NCTE Act 1993 to visit the institution. The inspection of the institution was conducted on 07.06.2008.

3. AND WHEREAS, the matter was considered by the WRC in its 104th meeting held on July 19-21, 2008 and the Committee decided as under:-

"WRC considered the VT report alongwith original file and all relevant documents and decided to serve show cause notice u/s 17 of NCTE Act for following deficiencies:-

- 1. Built-up area is inadequate for PTC and B.Ed. course.
- 2. Number of teachers is inadequate.
- 3. Salary is not being paid through bank.
- 4. Books in library are inadequate.
- 5. Books in library are meant for courses other than teacher education.

WRC also decided to serve show cause notices to other teacher training program (P.T.C) being run by the Institution."

4. AND WHEREAS, show cause notice was issued to the institution on 02.08.2008. In response, the institution had submitted reply vide letter dated 16.08.2008.

5. AND WHEREAS, the matter was considered by the WRC in its 110th meeting held on November 12-14, 2008 and the Committee decided as under:-

"WRC considered the reply received alongwith original file and all relevant documents and observed that-

- 1. Teaching staff is not as per NCTE norms.
- 2. Building plan is not in the name of the trust.
- Documentary proof in support of the availability of books are not produced/made available.

So recognition withdrawn w.e.f. academic year 2009-2010"

6. AND WHEREAS, Withdrawal order was issued to the institution vide order No.WRC/APW04673/ 323451/110th/2008/48329-48334 dated 18.12.2008.

7. AND WHEREAS, WRC in its 145th meeting held on February 17-18, 2011 considered the matter in the light of directions passed by the Hon'ble High Court of Gujarat at Ahmedabad in SCA No.3205/2009 & related matters and decided to cause inspection. Accordingly, the inspection of the institution was conducted on 05.05.2011.

8. AND WHEREAS, the matter was considered by WRC in its 150th meeting held on June 2-4, 2011 and the Committee decided as under:-

"Show Cause Notice under section 17 (1) of NCTE Act, 1993 be issued to the institution to submit written representation within 30 days before passing withdrawal order on the following points:

Approved Principal and Staff list by examining body not submitted.

- The land documents duly certified by the competent authority was not submitted along with the application that was required as per the section 7(d) of NCTE norms and standards 2002 or as per Section 8(5) of NCTE norms and Standards 2005.
- After considering the Visiting Team Report of inspection conducted as per directions of Hon'ble High Court of Gujrat in S.C.A. No. 3205/2008 & related matters, along with other related documents WRC decided that before passing withdrawal orders Show Cause Notice be issued to the institution under section 17 (1) of NCTE Act, 1993 that the institution should submit written representation within 30 days of the issue of Show cause notice."

9. AND WHEREAS, show cause notice was issued to the institution vide letter No.WRC/APW04673/323451/150/2011/79086 dated 21.06.2011. In response, the reply submitted by institution vide letter dated 15.07.2011.

10. AND WHEREAS, the matter was considered by the WRC in its 153rd meeting held on July 28-30 and the Committee decided as under:-

"Principal not appointed.

Hence, the recognition for B.Ed. course is withdrawn under section 17(1) of the NCTE Act, 1993 from the end of the academic session next following the date of withdrawal order."

11. AND WHEREAS, Withdrawal order was issued to the institution vide order No. WRC/APW04673/323451/153rd/2011/82226-82232 dated 03.10.2011.

12. AND WHEREAS, the institution had filed an appeal before the Appellate Authority at NCTE, New Delhi and the Appellate Authority vide order No.89-427/2011 Appeal/1st meeting-2012 dated 15.02.2012 has remanded back the matter to WRC for re-examination of the matter in the light of Council's observations and for taking decision thereafter.

13. AND WHEREAS, the institution had filed SCA No.6487 of 2012 before the Hon'ble High Court of Gujarat at Ahmedabad and the Court vide Interim Order dated 10.05.2012 had directed that the respondent No.01 (WRC) should pass, within further period of 5 days from service of this order, a fresh order in compliance of the directions by Appellate Authority vide order dated 15.02.2012.

14. AND WHEREAS, the matter was considered by the WRC in its 166th meeting of WRC held on July 9-10, 2012 and the Committee decided as under:-

"The case file was examined carefully and the order of Hon'ble High Court of Gujarat was also seen carefully. In this case the NCTE hqs had accepted the appeal against the withdrawal order of WRC with the direction that WRC should re-examine the matter. The institution has also approached the Hon'ble High Court who ordered that Respondent No. 1 (WRC) should pass an appropriate order within five days of the service of their order, failing which the original order of recognition would be restored. The WRC could not pass the order in the stipulated time because the learned counsel did not returned the file to WRC (the file was received from the Counsel in the first week of July). An examination of the file shows that the petitioner institution has only submitted the order of the Hon'ble High Court but had not submitted the appointment information of the Principal for his institution.

Hence Show Cause Notice be issued to the institution on this ground."

15. AND WHEREAS, Show Cause Notice was issued to the institution on 08.08.2012. In response, the institution had submitted reply on 03.09.2012.

16. AND WHEREAS, the matter was considered by WRC in its 173rd meeting of WRC held on November 5, 2012 and the Committee decided as under:-

"The case file was seen and the order of the Hon'ble High court was perused carefully. The institution has submitted documents relating to points about the Principal's qualification. However, the institution has not given any information regarding the increase of built-up area as required under Clause 8(13) of Regulation 2009, since he is running two courses. The built-up area required for two courses is 3000 sq. ft. Hence Clarification be issued on this ground."

17. AND WHEREAS, clarification letter was issued to the institution on 12.12.2012 and in response, the institution submitted reply on 14.01.2013.

18. AND WHEREAS, the matter was placed in the 179th meeting of WRC held on February 11-13, 2013 and the Committee decided as under:-

"The case file was seen very carefully. Following the order dated 10.05.2012 of Hon'ble High Court of Gujarat at Ahmedabad, the institution was continuing because the recognition withdrawal order dated 03.10.2011 remain unenforced. Now, the institution has informed that it has closed the existing P.T.C. course. Thus, the institution has now sufficient land for running the B.Ed. course.

Hence, recognition is continued."

19. AND WHEREAS, continuation order for recognition issued on 01.03.2013.

20. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No.WRC/APW04673/323451/2015/147434-441 dated 31.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students) from the academic session 2015-2016.

21. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on 09.08.2016.

22. AND WHEREAS, in response to the aforesaid show cause notice, reply submitted by the institution on 30.08.2016.

23. AND WHEREAS, the matter was considered by the WRC in its 283rd meeting held on 14th-15th November, 2017 and the committee decided as under:-

"The case file was seen. As per Revised Recognition order, the institution has submitted documents as required. However, the staff profile approved by the affiliating body should be submitted in original.

Building Completion Certificate singed by a Govt. Engineer and FDRs of Rs. 12.00 lakhs (in joint name) should be submitted in original.

Compliance should be submitted by the institution within one month, failing which action will be initiated as per NCTE Regulations, 2014."

Accordingly, letter was issued to the institution on 17.11.2017.

24. AND WHEREAS, the matter was considered by the WRC in its 366th meeting held on July 12 & 14, 2022 and the Committee decided as under:-

"The original file of the Institution, Visiting Team Report along-with other related documents were carefully examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-

- Reply of Final Show Cause Notice issued on 17.11.2017 has not received within the stipulated time.
- Committee decided to withdraw the recognition for B.Ed. Course.
- The institution has also not filled up the Performance appraisal Report.

In view of the above, the Committee decided to withdraw the recognition of B.Ed. programme U/S 17 of the NCTE Act 1993."

25. **NOW THEREFORE,** recognition granted to the institution, namely, **SHRI APEX EDUCATION TRUST SANCHALIT B.ED COLLEGE, RAVAPUR-GHUNDA ROAD, ROYAL AVENUE SOCIETY, LAJAI TA. TANKARA, DIST. RAJKOT, GUJARAT** for B.Ed. course (Code No.APW4673/323451) is hereby withdrawn under section 17 of the NCTE Act 1993 with effect from the end of the academic session next following the date of the communication of the said order.

Further, if the institution is not satisfied by the order, it may prefer an appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through 'online mode' available on NCTE's website <u>www.ncte-india.org</u> within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
