RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to SHREE NATH B.ED COLLEGE RUN BY MARATHA SHIKSHAN SANSTHAS, PAITHAN, DIST-AURANGABAD, MAHARASHTRA under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/5-6/105th/2008/39467 dated 20.08.2008.

- 2. AND WHEREAS, Revised Recognition order was issued to SHREE NATH B.ED COLLEGE RUN BY MARATHA SHIKSHAN SANSTHAS, PAITHAN, DIST-AURANGABAD, MAHARASHTRA vide order No. F. No. WRC/APW04855/123597/2015/144276-326 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic unit of (50 students) from the academic session 2015-2016.
- 3. AND WHEREAS, Compliance was not submitted as per regulations 2014.
- 4. **AND WHEREAS,** the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- 5. **AND WHEREAS,** a Show Cause notice was issued to the institution on 04.01.2017 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.
- 6. **AND WHEREAS**, the reply of show cause notice was submitted by the institution on 09.03.2017.
- 7. **AND WHEREAS**, the matter was placed in 292nd Meeting held on May 17-19, & 2018 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -
 - "...The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 04.01.2017 was issued for non-compliance.

The institution vide reply dated 04.02.2017 has submitted the staff profile of 1+6 faculty members as against the requirement of 1+7. The staff profile needs to be submitted in original approved by the Registrar in the NCTE format (enclosed). Since the institution has requested for reduction in intake from two units to one unit, the requirement of staff is 1+7 as per Appendix-IV of NCTE Regulations, 2014.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

- 8. **AND WHEREAS,** a letter was issued to the institution on 31.05.2018 as per decision of WRC, and its reply received from the institution on 18.06.2018.
- AND WHEREAS, the matter was placed in 297th Meeting held on September 13-14, 2018 of WRC and the Committee decided that.

"... The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 04.01.2017 followed by a compliance letter dated 31.05.2018 were issued.

The institution replied on 18.06.2018. An examination of the staff shows that the Principal and the faculty members at S.No.2-5 are approved by the University Faculty members at S.No.6-8 are selected by the local body and not by the duly constituted Selection Committee constituted by the University.

Secondly, the institution has not submitted FDRs for Rs.12.00 lakhs.

Hence, Recognition is withdrawn from the end of the academic session."

- 10. AND WHEREAS, the Withdrawal order was issued to the institution on 22.09.2018.
- 11. **AND WHEREAS**, the institution filed an Appeal to the Council on 26.11.2018 and the Council vide its order dt. 26.09.2019 remanded back the case to the WRC, NCTE for necessary action.
- 12. **AND WHEREAS,** the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 11725/2021 dt. 12.10.2021.the operative part is produced here below:-

The NCTE is directed to issue an order of restoration of recognition within one week and to reflect the correct status of the petitioner on its website as well as communicate it to the petitioner's affiliating University and to the concerned departments of the State Government within one week. The Petitioner will be entitled to participate in counselling and admit students for the year 2021-22 and all subsequent years until and unless a fresh withdrawal order is passes against it. I am informed that counselling for the year 2021-2022 has not yet begun.

- 13. NOW THEREFORE, recognition of the institution viz SHREE NATH B.ED COLLEGE RUN BY MARATHA SHIKSHAN SANSTHAS, PAITHAN, DIST-AURANGABAD, MAHARASHTRA for B.Ed. course with an annual intake of 100 students (Two unit) is hereby restored.
- 14. The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dt. 31.05.2015.
- 15. The office order F.No. WRC/APW04855/123597/B.ED/M.H/2021/218277-218282 dt. 22.11.2021 be treated as cancelled.
