**SHIFTING ORDER**

WHEREAS, the institution, namely, Gyanodaya Mahavidyalaya, Khasra No. 30, 36/1,37/1 Jaisiagar Sagar , District – Sagar, Madhya Pradesh for B.P.Ed. course of one year duration with annual intake of 50 students vide Order No. WRC/5-6/106<sup>th</sup>/2008/39847 dated 26.08.2008.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised order was issued to the institution vide WRC's Order No. WRC/APW06825/224168(A)/Revised Order/M.P./2015/13583 dated 19.05.2015 for conducting B.P.Ed. Course of two years duration with an annual intake of 100 Students from the academic session 2015-16.

3. AND WHEREAS, the institution has submitted application for Shifting of Premises on 21.07.2023. Khasra No. 30, 36/1,37/1 Jaisiagar Sagar , District – Sagar, Madhya Pradesh to Khasra No. 285, 286/1, 180/2, 283, 290, 291/1, 278, 279/2, Mara Imaliya Sagar, Madhya Pradesh.

4. AND WHEREAS, As per decision take by WRC in its 399<sup>th</sup> meeting held on 09<sup>th</sup> to 10<sup>th</sup> January, 2024, the inspection was conducted by the Visting Team of NCTE through virtual mode on 12.02.2024 for shifting of premises of the institution.

5. AND WHEREAS, the VTR was placed before the WRC in its 400<sup>th</sup> meeting held on 13<sup>th</sup> February, 2024 and WRC committee decide to issued Show Cause Notice and the Show Cause Notice issued to the institution on 16.02.2024.

6. AND WHEREAS, the institution has submitted reply of Show Cause Notice received in WRC office on 06.03.2024. The matter was placed before the WRC in its 402<sup>nd</sup> meeting held on 27<sup>th</sup> March, 2024 and the committed decided as under :-

“The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decides as under:

**Shifting of institution to its new premises is permitted.**

6. NOW THEREFORE, in exercise of the powers vested under section 14(3)(a) of NCTE Act. 1993, the permission under cluse 8(9) of NCTE Regulations, 2014, is hereby granted to Gyanodaya Mahavidyalaya, Khasra No. 30, 36/1,37/1 Jaisiagar Sagar , District – Sagar, Madhya Pradesh to Gyanodaya Mahavidyalaya, Khasra No. 285, 286/1, 180/2, 283, 290, 291/1, 278, 279/2, Mara Imaliya Sagar, Madhya Pradesh.” with immediate effect for conducting its B.P.Ed. Course.


