RESTORATION ORDER

WHEREAS, the institution, namely, "T.D. D.ED. COLLEGE, 11/415, INDIRA NAGAR UNIVERSITY ROAD REWA-486001, MADHYA PRADEH was granted recognition for D.El.Ed. Course two years with annual intake of 50 students vide Order No. WRC/5-6/90/2006 dated 30.10.2006

- 2. **AND WHEREAS,** as per decision of WRC taken in its 322th meeting said recognition was withdrawn of the institution and withdrawal order was issued to the institution vide order dated-18.12.2020.
- 3. **AND WHEREAS**, institution had filed an appeal before the council (NCTE) under section 18 of NCTE Act, 1993. The Appellate Authority vide its order dated 04.10.2021 remanded back the case to the WRC, NCTE. The institution submitted the reply/documents in response to Appellate Authority order.
- 4. **AND WHEREAS,** in the light of order dated 04.10.2021 passed by the Appellate committee the case was considered by WRC in its 359th Meeting held on 18th April, 2022 and WRC decided to issue show cause notice u/s 17 and show cause notice u/s 17 was issued to the institution on 26.05.2022.
- 5. AND WHEREAS, the institution has not submitted reply of show cause notice u/s 17. The matter was placed before the WRC in its 402nd meeting held on 27th March, 2024 and the WRC decided as under:-

"The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the WRC decides that restoration order be issued to the institution".

6. **NOW THEREFORE**, In terms of the above decision taken by WRC in its 402th Meeting held on 27th March, 2024, the recognition to the institution namely "T.D. D.ED. COLLEGE, 11/415, INDIRA NAGAR UNIVERSITY ROAD REWA-486001, MADHYA PRADEH for conducting D.El.Ed. Course of two years duration with an annual intake of 50 Students is hereby restored.
