ORDER







4. The institutions shall ensure the fulfillment of the following :-


- (a) The institutions shall maintain the teaching staff strength of 1+5 for the sanctioned P.T.C. course and all the appointments would be on regular basis on an approved scale of payment of the candidates having fulfilled eligibility condition prescribed by NCTE. The institute concerned shall send a report in this regard to WRC of NCTE within 30 days, in terms of clause 7 (12) of the NCTE Regulations 2005.
- (b) The institutions shall note that with regard to NET / SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.7.2006.
- (c) The institutions shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (d) The institutions shall within one month of the receipt of the Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an authorized official of the Regional Committee.
- (e) That the Reserve fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the managements / institutions.
- (f) Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government etc.
- (g) The institutions shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- (h) The institutions shall regularly update their website.
- (i) The institutions intending to run the teachers training programme approved above in a rented premises are required to submit report in compliance of the requirement of NCTE Regulations on the subject regarding their shift to permanent building.

3. If any of the institutions contravene any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and / or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act 1993. The NCTE Hqrs. May also cause inspections under Section 13 of NCTE Act, 1993.



ORDER

WHEREAS, recognition was granted to the institution, namely to RUPAL P.T.C. COLLEGE, AT & POST-RUPAL, TALUKA- HIMMATNAGAR, DIST.-SABARKANTA, GUJARAT. Under section 14(3)A of NCTE Act, 1993 for conducting P.T.C. course One intake 50 Students vide order No. WRC/NCTE/ APW03317/322381/5-6/88/C-2006 dated 27.02.2007.

AND WHEREAS, The Institution has submitted an application on 24.04.2008 for Additional intake 50 students of P.T.C. course from the next following academic session.

AND WHEREAS, the WRC in its 102th meeting considered your letter dt. 24.04.2008, requesting this office for Additional intake of PTC course being conducted by your Society/ Trust and decided to accept your institution's request.

AND WHEREAS, the matter was placed in 107th Meeting of WRC held on Aug. 11-12th, 2008 and the Committee decided that "...issue Show Cause Notices to the institution of the condition maintained in Affidavit."

AND WHEREAS, a Show cause notice was issued to institution on 21.08.2008.

AND WHEREAS, the reply of show cause notice was submitted by the institution on 15.09.2008.

AND WHEREAS, the matter was placed in 109th Meeting of WRC held on October 20th-21th, 2008 and the Committee decided that The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation were made:

"In response to the Show Cause Notice dated 21.08.2008, the institution has submitted all required documents." AND WHEREAS, the Letter of Intent (LOI) was issued to the institution on 28.11.2008.

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from affiliating body in the form of N.O.C. and report, recommendation of the state Government, the Committee is satisfied that the institution has adequate financial resources, accommodation, library, qualified staff, infrastructure laboratory and that it fulfils such other conditions required for proper functioning of the institution for P.T.C. course as determined by regulations.

AND WHEREAS, WRC Considered the application of institution for Additional in intake of 50 Students with all the requirement as per NCTE Regulations and WRC NCTE decided to permit the Additional intake of 50 students for P.T.C. course to RUPAL P.T.C.
