WITHDRAWAL ORDER

WHEREAS, WRC-NCTE had granted the recognition to Shree RATANBA MAHILA COLLEGE OF EDUCATION, VISHVABHARATI EDUCATION SANSTHAN, C/O ARTS COLLEGE HMT. SHAMLAJI N.H. 8 CHAR RASTA, RAJENDRANAGAR, TALUKA – BHILODA, SABARKANTHA, GUJARAT – 383276 order No. WRC/2-32/60/2004/3934 dated 11.06.2004 for conducting PTC course with an annual intake of 50 students from the academic session 2004-2005.

- **2. AND WHEREAS,** after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Ratanba Mahila College Of Education, Vishvabharati Education Sansthan, C/O Arts College Hmt. Shamlaji N.H. 8 Char Rasta, Rajendranagar, Taluka Bhiloda, Sabarkantha, Gujarat 383276 offering P.T.C. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.
- AND WHEREAS, the matter was considered by WRC in its 316th meeting of WRC held on 27th 28th August and 4th September, 2020 wherein the committee decided as under: -

"The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision."

- **4. AND WHEREAS,** Show Cause Notice no. WRC/APW00964/322167/PTC/316th/2020/209810-209813 dt. 21.09.2020 was issued to the institution.
- **5. AND WHEREAS,** the institution vide letter dt. 05.10.2020 has submitted the reply and the matter was placed before the WRC in its **341**st meeting held on **17**th **18**th **August, 2021** and the Committee decided as follows:-

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided as under:-

a. The institution is running the institution on a rented premises.

b. No admissions have been made in the institution since the academic session 2012-2013.

In view of the above, the Committee decided that the recognition granted to the institution be withdrawn u/s 17 of the NCTE Act for PTC course.

- **6. Now, therefore,** the recognition of Ratanba Mahila College Of Education, Vishvabharati Education Sansthan, C/O Arts College Hmt. Shamlaji N.H. 8 Char Rasta, Rajendranagar, Taluka Bhiloda, Sabarkantha, Gujarat 383276 for conducting P.T.C. programme of two years duration with an annual intake of 50 seats (one basic unit of 50 students), is **hereby withdrawn** in terms of Section 17(1) of the NCTE Act, 1993.
- 7. Further, if the institution is not satisfied by the decision, it may prefer an appeal to National Council for Teacher Education, G-7, Sector-10, Dwarka, New Delhi 110075 against this decision under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this letter through online mode, on the NCTE Website www.ncte-india.org.
