RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely **SSMM B.ED. COLLEGE, PLOT NO. 176/1, STREET NO. 0, VILL.+P.O. CITY-NANDGAON PETH, THE. AMRAVATI, DIST. AMRAVATI-444902, MAHARASHTRA** vide Order No. WRC/APP2044/203<sup>RD</sup>/2014/16293, 97, 98, 99, 116300, 02, 03 dated 03.03.2014 for B.Ed. course of one (1) year duration with an annual intake of 100 students from the academic session 2014-2015.

**AND WHEREAS**, the revised order was issued to the institution vide order no. WRC/APP2044/2015/148267-277 dt. 31.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

**AND WHEREAS**, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided as under:-

*"The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."*

**AND WHEREAS**, Show Cause Notice was issued to the institution on 21.12.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- **Staff Profile for the session 2015-16 duly approved by the affiliating body.**
- **Originally notarized Change of Land Use/Non Encumbrance Certificate/Building plan and Building Completion Certificate.**

**AND WHEREAS**, a letter received from the institution dt. 12.02.2017 regarding grant of permission to conduct B.Ed. course of one unit (50 students) from the session 2017-2018. An order was issued to the institution dt. 02.02.2017 regarding reduce intake from 2 units (100 students) to 1 unit (50 students) to conduct of B.Ed. course.

**AND WHEREAS**, Now, the institution has submitted reply of Show Cause Notice vide letter dt. 31.05.2021 received on 08.06.2021. The matter was considered by WRC in its 339<sup>th</sup> meeting of WRC held on 28<sup>th</sup> – 30<sup>th</sup> July 2021 and the committee decided as under:-

*"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:*

*The institution has submitted all required documents which were considered by the Committee and found fit the case for issuance of continuation Recognition Order.*

**In view of above, the Committee decided as under:**

**Recognition of the institution be restored for the B.Ed programme with an intake of two unit of 50 students."**

**NOW, THEREFORE**, the Western Regional Committee hereby restores recognition of **SSMM B.ED. COLLEGE, PLOT NO. 176/1, STREET NO. 0, VILL.+P.O. CITY-NANDGAON PETH, THE. AMRAVATI, DIST. AMRAVATI-444902, MAHARASHTRA** for B.Ed course with an intake of two units of 50 students.
