WITHDRAWAL ORDER

WHEREAS, the institution, namely, **The New Progressive College of Teachers Education, The New Progressive Education Trust, Prasad Building, Vishnagar Road, Mehsana-384001, Gujarat** was granted recognition by WRC NCTE for M.Ed. Course vide order No.WRC/5-6/114th/2008/51836-51841 dated 28.02.2009.

2. AND WHEREAS, NCTE, New Delhi vide its letter No.F.No.49-4/2010/PT/NCTE (N&S) dated 30.07.2010 had communicated to intimate the institution having approved M.Ed. programme to enhance the existing intake to 35 students from the current session 2010-2011 as notified National Council for Teacher Education Amendment Regulation, 2010 in the Gazette of India on 26th July, 2010.

3. AND WHEREAS, the matter was placed before in 140th WRC meeting held on September 14-15, 2010 and the Committee decided as follows:-

"The decision of the NCTE Hqrs to enhance the intake for the M.Ed. programme from 25 to 35 from the current session (2010-2011) be sent to all the concerned institution."

4. AND WHEREAS, permission was granted to the institution vide order dated 09.10.2010 for 35 students in M.Ed. course.

5. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised order was issued to the institution vide order No.WRC/APW04679/325068/2015/175134,135,136,137,138, 139,140 dated **27.10.2016** for conducting M.Ed. programme of two year duration with an annual intake of 50 students (one basic unit of 50 students each) from the academic session 2015-16.

6. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on **09.02.2018**.

7. AND WHEREAS, in response to the aforesaid show cause notice, reply submitted by the institution vide letter dated 26.04.2018 received in WRC on 02.05.2018.

8. AND WHEREAS, the matter was placed in 336th WRC meeting held on March 24-25, 2021 and Committee decided as follows:-

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-

- i. The institution is required to submit certified copy of land documents issued by concerned Tehsildar / Revenue officer, (if the same are in Regional Language the institution is also required to submit notarized copy of English version of land documents).
- *ii.* The institution is required to submit an attested / notarized copy of Non-Encumbrance Certificate issued by the Competent Authority.

- iii. The institution is required to submit an attested/notarized copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognized Teacher Education programme).
- iv. Land possession certificate issued from Competent Authority is not submitted.
- v. The institution has submitted a photocopy of staff list duly conditionally approved by the I/C Registrar Hemchandracharya North Gujarat University, Patan, Gujarat which is not acceptable as per NCTE Regulations. 2014.
- vi. Building Completion Certificate issued from Hasmukhbai N. Mevada Architectural Interior Muni Lic. No. Madavda Architectural Interior Muni Lic No. Mada- 10, 12/B Pruthvi Complex Opp. Pashabhai Petrol Pump, Highway, Mehsana Gujrat-384002 which is not Govt. Authority.
- vii. The institution has submitted Building Plan but approving authority is not readable.

Hence, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 to submit the notarized / Certified documents on the above-mentioned grounds within 30 days from the date of issue of this Final Show Cause Notice."

9. AND WHEREAS, Final Show Cause Notice was issued to the institution on 07.04.2021.

10. AND WHEREAS, in response to the aforesaid notice, reply submitted by the institution vide letter dated **14.08.2021** received in WRC on 19.08.2021.

11. AND WHEREAS, the matter was placed in the WRC in its 374th meeting (PART-1) held on October 18-19, 2022 and the Committee decided as under:-

"The original file of the Institution along-with other related documents, representation dated 14.08.2021 in response to final show cause notice dated 07.04.2021 for compliance of deficiencies were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Show cause notice 09.02.2018 was issued to the institution due to non-compliance of conditions mentioned in the revised recognition order dated 27.10.2016.
- Reply submitted by the institution was considered by WRC in its 336th meeting held on 24-25 March, 2021 and as decided by WRC, final Show Cause Notice dated 07.04.2021 was issued to the institution to comply deficiencies mentioned therein.
- Photocopy of reply vide letter dated 14.08.2021 (available on record) submitted by the institution was considered by WRC.

The institution is still deficient on the following in light of NCTE Regulations, 2014 and subsequent amendments published time to time:

- Total land area not mentioned in the submitted certified copy of registered land documents.
- Non-encumbrance certificate issued by competent authority not submitted.
- In the submitted property card, plot /survey no. not mentioned. Land area is not as per NCTE norms.
- Attested /Notarized copy of approved building plan exclusively earmarking the more than one teacher education programme, if running by the institution is not attached in the reply.
- Land possession certificate from competent authority is not submitted.
- Experience certificate of Principal/HOD substantiating Ten years of professional experience in teacher education not submitted.
- The institution has not submitted approved building plan showing plot/khasra no., total land area, total built up area, location of the building approved by competent authority.

In view of the above, the Committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for M.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

12. **NOW THEREFORE**, recognition granted to the institution, namely, **The New Progressive College of Teachers Education**, **The New Progressive Education Trust**, **Prasad Building**, **Vishnagar Road**, **Mehsana-384001**, **Gujarat** for M.Ed. course (Code No.APW04679/325068) for an annual intake of 50 students (One basic unitof 50 students each) is hereby withdrawn under section 17 of the NCTE Act 1993 with effect from the end of the academic session next following the date of the communication of the said order.

Further, if the institution is not satisfied by the order, it may prefer an appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through 'online mode' available on NCTE's website <u>www.ncte-india.org</u> within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
