WITHDRAWAL ORDER

WHEREAS, the institution, namely, The New Progressive College of Teacher's Education Run by The New Progressive Education Trust, Mehsana Prasad Building, Visnagar Road, Mehsana-384001 Gujarat was granted recognition by WRC, NCTE for B.Ed. Course vide order No.WRC/2-32/323070/56/2004/ 664 dated 20.02.2004.

- AND WHEREAS, Formal recognition order was issued to the institution vide Order No.WRC/5-6/APW00063/323070/56/2007/C-20904-909 dated 31.07.2007.
- AND WHEREAS, after promulgation of NCTE Regulations, 2014 the revised order was issued to the institution vide order No.WRC/APW00063/323070/2015/140986-993 dated 31.05.2015 for conducting B.Ed. programme of two-year duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016.
- 4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on 04.08.2017.
- AND WHEREAS, in response to the aforesaid show cause notice, reply submitted by the institution vide letter dated 20.11.2017 received in WRC on 23.11.2017.
- AND WHEREAS, the matter was placed in 291st WRC meeting held on April 26-27, 2018 and the Committee 6. decided as follows:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 04.08.2016 was issued. The institution has submitted a staff profile of 1+14 faculty members. Out of these, 1+9 are approved by the Registrar and lecturers from S.No.10-15 are not approved. The institution is required to submit the staff profile of 1+15 faculty members (as per Appendix-IV of NCTE Regulations, 2014 and subsequent NCTE notification published on 09.06.2017) approved by the Registrar in original.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

Accordingly, letter was issued to the institution on 04.05.2018.

- AND WHEREAS, in response to the aforesaid letter, reply submitted by the institution vide letter dated 14.05.2018 and 11.08.2018.
- AND WHEREAS, the matter was placed in the WRC in its 374th meeting (PART-1) held on October, 18th -19th 2022 and the Committee decided as under:-

"The original file of the Institution along-with other related documents, representation dated 14.05.2018, 11.08.2018 in response to letter dated 04.05.2018 for compliance of deficiencies were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Show cause notice dated 04.08.2017 was issued to the institution due to non-compliance of conditions mentioned in the revised recognition order dated 31.05.2015.
- Reply submitted by the institution was considered by WRC in its 291st meeting held on 26-27 April. 2018 and accordingly, the institution was communicated vide letter dated 04.05.2018 asking the institution to submit the staff profile of 1+15 faculty members (as per Appendix-IV of NCTE Regulations, 2014 and subsequent NCTE notification published on 09.06.2017) approved by Registrar in original.

The institution is still deficient on the following in light of NCTE Regulations, 2014 and subsequent amendments published time to time:

- Original faculty list comprising 1 Principal + 15 faculty members (as per Appendix-IV of NCTE Regulations, 2014 and subsequent NCTE notification published on 09.06.2017) approved by Registrar of affiliating not submitted.
- Scanned copy of Faculty list submitted by the institution has been conditionally approved by Hemchandracharya North Gujarat University, Patan.
- As per the list, University approval for selection/appointment of Principal is under process and Principal is appointed on ad-hoc basis.
- Experience certificate of Principal substantiating eight years of teaching experience in a Secondary Teacher Education Institution as per NCTE Regulations, 2014 not submitted.
- Faculty reflected at sl.no.1 does not possess 55% at PG level as per NCTE Norms and Regulations, 2014.
- Faculty is not qualified as per NCTE Regulations, 2014 as amended vide notification dated 09.06.2017.

In view of the above, the Committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

9. **NOW THEREFORE**, recognition granted to the institution, namely, **The New Progressive College of Teacher's Education Run by The New Progressive Education Trust, Mehsana Prasad Building, Visnagar Road, Mehsana-384001 Gujarat for B.Ed. course (Code No.APW00063/323070) for an annual intake of 100 students (two basic units of 50 students each) is hereby withdrawn under section 17 of the NCTE Act 1993 with effect from the end of the academic session next following the date of the communication of the said order.**

Further, if the institution is not satisfied by the order, it may prefer an appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through 'online mode' available on NCTE's website www.ncte-india.org within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
