## WITHDRAWAL ORDER

WHEREAS, the institution, namely, LATE PUNDLIKRAO TIRPUDE COLLEGE OF EDUCATION, AT KHASARA NO.276/1, KHEDEPAR ROAD, SAWARI (MURMADI), TAH-LAKHANI, BHANDARA-445804, MAHARASHTRA was granted recognition by WRC, NCTE for B.Ed. Course of one year duration with intake of 100 from the academic session 2008-2009 vide Order No.WRC/5-6/102/2008/29888-29894 dated 01.03.2008.

- 2. **AND WHEREAS,** after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No.WRC/APW04613/123565/2015/141180-187 dated 31.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016.
- 3. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255<sup>th</sup> WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on 03.04.2017.
- 4. **AND WHEREAS**, in response to the aforesaid show cause notice, reply not submitted by the institution.
- 5. **AND WHEREAS**, the matter was placed in the 371<sup>st</sup> meeting held on September 21-22, 2022 and the Committee has decided the following:-

"The original file of the Institution along-with other related documents were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- 1<sup>st</sup> Show cause notice issued dated 03.04.2017.
- The institution has not submitted reply in response to first show cause notice and the stipulated time period of compliance has already been over.
- The institution is still deficient on the grounds mentioned in the show cause notice dated 03.04.2017.
- The institution has also not submitted Performance Appraisal Report (PAR) for the academic session 2020-2021.

In view of the above, the Committee decided that final Show Cause Notice be issued to the institution u/s 17 of the NCTE Act for B.Ed. programme to submit reply to SCN accompanied by an original affidavit within 30 days from the date of uploading of minutes on the website failing which the WRC will take decision as deemed fit as per the provisions contained in the NCTE Act and Regulations."

- 6. **AND WHEREAS**, final show cause notice issued to the institution dated 29.09.2022.
- 7. **AND WHEREAS**, in response to the aforesaid final show cause notice, reply not submitted by the institution till date.
- 8. **AND WHEREAS**, the matter was considered by WRC in its 375<sup>th</sup> meeting held on November 18-19, 2022, and the Committee decided as under:-

"The original file of the Institution along-with other related documents, were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Recognition was granted for B.Ed. course vide order dated 01.03.2008.
- Revised order was issued dated 31.05.2015 in pursuance of NCTE Regulations, 2014.
- Show cause notice dated 03.04.2017 was issued in the matter of compliance of conditions of revised recognition order.
- No reply submitted in response to show cause notice.
- Performance Appraisal Report for the academic session 2020-2021 has not been submitted by the institution.
- Final Show cause notice u/s 17 of NCTE Act, 1993 was issued dated 29.09.2022.
- No reply submitted by the institution in response to final show cause notice.

In view of the above, the Committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

- 9. **NOW THEREFORE,** in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition granted to the institution, namely, LATE PUNDLIKRAO TIRPUDE COLLEGE OF EDUCATION, AT KHASARA NO.276/1, KHEDEPAR ROAD, SAWARI (MURMADI), TAH-LAKHANI, BHANDARA-445804, MAHARASHTRA for B.Ed. course (Code No.APW04613/123565) for an annual intake of 100 students (two basic units of 50 students each) is hereby withdrawn with effect from the end of the academic session next following the date of communication of the said order.
- 10. Further, if the institution is not satisfied by the order, it may prefer an appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through 'online mode' available on NCTE's website www.ncte.gov.in within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
