Whereas, the WRC had granted recognition to Sardar Patel B.Ed. College, Seema Hall, 100 Ft.

Road, Satellite, Opp. Vrajdham, Ahmedabad, Gujarat - 380015 for conducting B.Ed. course of one year duration with an annual intake of 100 students vide order No. WRC/5-6/106th/2008/40186 dt. 28.08.2008.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Sardar Patel B.Ed. College, Seema Hall, 100 Ft. Road, Satellite, Opp. Vrajdham, Ahmedabad, Gujarat - 380015 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 09.01.2015 from the institution, a revised recognition order no. WRC/APW06410/323544(AddI)/APW01132/323197/2015/143063 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit followings documents in compliance of the NCTE Regulations, 2014 :-

- 1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
- 2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
- 3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the institution hadn't submitted the desired documents in compliance of NCTE Regulations, 2014 and matter was placed before the WRC in its 255th meeting held on June 22nd -24th, 2016. The Committee decided to issue Show Cause Notice dt. 08.08.2016 to the institution.

And whereas, the institution vide letter no. 36/2016-17 dt. 26.08.2016 has submitted the documents in response to show cause notice dt. 08.08.2016.

And whereas, reply dt. 26.08.2016 submitted by the institution was placed before the WRC in its 275th meeting held on May 30th - 31st, 2017 and the Committee decided as follows :-

"The case file was seen. In response to the Show Cause Notice issued on 08/08/2016, the institution vide letter dt. 26/08/2016 has submitted a list of 1 Principal and 17 faculty members approved by the Registrar, Gujarat University.

However, the following deficiencies are seen:-

- Lecturers at serial no. 2, 3, 7, 12, 13 (Makwana Gayatri), and 14 (Prajapati Ishwarbhai) are not i) qualified since they do not have the required percentage at the PG level.
- Staff members at serial nos. 4 (Soni Vasant Kumar) is also seen in faculty list of other ii) institutions (323085 and 323463).
- The latest Building Completion Certificate approved by the competent authority (RES/Govt. iii) Engineer) has not been submitted.
- Also, FDRs in joint name have not been submitted.

Compliance in this matter should be submitted within 1 month failing which action will be taken under section 17 of the NCTE Act, 1993."

And whereas, the WRC vide letter dt. 05.06.2017 sought the clarification from the institution.

And whereas, the WRC vide letter no. WRC/APW06410/323544/GJ/2017/186799 dt. 19.06.2017 and reminder letter dt. 04.07.2017 had requested the Vice-Chancellor, Gujarat University, Navrangpura, Ahmedabad for verification of staff Profile, for session 2015-2016, submitted by the institution.

And whereas, the Gujarat University vide letter no. Academic/9083/2017 dt. 20.07.2017 had informed as follows :-

"In connection with the above cited subject & reference, We are to state that our primary report and office record of staff profile for the Academic year 2015-2016 of above mentioned colleges are not certified at our end. The committee is formulated for further scrutiny. Please note that the report will be submitted after the complete scrutiny at our end."

And whereas, the institution vide letter no. 10/2017-18 dt. 04.07.2017 has submitted the documents in response to clarification letter dt. 05.06.2017.

And whereas, reply dt. 04.07.2017 of institution along with letter dt. 20.07.2017 of the Registrar, Gujarat University was placed before the WRC in its 278^{th} meeting held on July 25^{th} – 26^{th} , 2017 and the Committee decided as follows:-

"The case file was seen. The Registrar of Gujarat University has informed that the staff list is not approved by the University and the case is being scrutinized by the committee.

The case will be considered as soon as the report is received from the University."

And whereas, the WRC vide letter dt. 01.08.2017 had conveyed the decision to the institution.

And whereas, the Gujarat University vide letter no. Academic/57489/2017 dt. 28.09.2017 has informed as follows :-

"The Committee verify the original documents of the said above institutes from our academic section and come to the following decision. All the staff profile of above mention colleges were not approved by our University office

And whereas, letter dt. 28.09.2017 of Gujarat University was placed in 282^{nd} meeting of WRC held on 24^{th} – 26^{th} October, 2017 and the Committee decided as follows:-

"The case file was seen. In the 278th meeting, the WRC had directed the office to ascertain from the Registrar of the Gujarat University about the veracity of the approval of the staff. The Registrar vide letter No. Academic/ 57489/2017 dated 28.09.2017 has informed that the staff profile was not approved by the University office.

Hence, Show Cause Notice be issued as to why the recognition should not be withdrawn. Reply should be submitted within one month."

And whereas, a show cause notice dt. 02.11.2017 was issued to the institution.

And whereas, the institution vide letter no. 25/2017-18 dt. 23.10.2017 has submitted the documents on 26.10.2017 in response to show cause notice dt. 02.11.2017.

And whereas, reply dt. 23.10.2017 submitted by the institution was placed before the WRC in its 286^{th} meeting held on 16^{th} – 17^{th} January, 2018 and the committee decided as follows:-

"The case file was seen. Show Cause Notice was issued to the institution on 02.11.2017 as to why recognition should not be withdrawn on account of submission of the staff profile. WRC also considered the reply of the institution dated 23.10.2017.

Since the WRC had doubts about the authenticity of the approving authority's signature, the staff profile was sent to the Gujarat University for verification. The University vide letter No.57489 dated 28.09.2017 has submitted the report of the scrutiny committee dated 12.09.2017. The Committee came to the conclusion that the staff profile of the college was not approved by the University office.

Hence, Recognition be withdrawn from the academic session 2018-2019."

Now, therefore, the recognition of Sardar Patel B.Ed. College, Seema Hall, 100 Ft. Road, Satellite, Opp. Vrajdham, Ahmedabad, Gujarat – 380015 for conducting B.Ed. programme of two years duration, with an annual intake of 100 seats (two basic units of 50 students), is **hereby withdrawn** from the academic session 2018-2019 in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the decision, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this decision under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this letter through online mode, on the NCTE website www.ncte-india.org.
