RESTORATION ORDER

215119

Whereas, recognition was granted to the institution, namely, SARDAR PATEL B.ED. COLLEGE, NEAR SEEMA HALL, 100 ROAD SATELITE, OPP. VRAJDHAM, AHMEDABAD GUJARAT – 380015 under section 14 of NCTE Act, 1993 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/2-32/74/323197/2005/7017 dated 25.08.2005 from the academic session 2005-2006.

- 2. And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014, **SARDAR PATEL B.ED. COLLEGE, NEAR SEEMA HALL, 100 ROAD SATELITE, OPP. VRAJDHAM, AHMEDABAD GUJARAT 380015** offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.
- 3. And whereas, after the receipt of affidavit dt. 09.01.2015 from the institution, a revised recognition order no. WRC/APW06410/323544(addl.)/APW01132/323197/2015/143063-93 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 200 students (four units of 50 students each) from session 2015-16 subject to fulfillment of the conditions mentioned here in before 31.10.2015.
- 4. And whereas, the institution vide letter dt. 23.10.2017 has submitted the documents and matter was placed in its **286**th meeting WRC held on **16**th **to 17**th **January, 2018** and the Committee decided as under: -

"The case file was seen. Show Cause Notice was issued to the institution on 02.11.2017 as to why recognition should not be withdrawn on account of submission of the staff profile. WRC also considered the reply of the institution dated 23.10.2017,

Since the WRC had doubts about the authenticity of the approving authority's signature, the staff profile was sent to the Gujarat University for verification. The University vide letter No.57489 dated 28.09.2017 has submitted the report of the scrutiny committee dated 12.09.2017. The Committee came to the conclusion that the staff profile of the college was not approved by the University office.

Hence, Recognition be withdrawn from the academic session 2018-2019."

- 5. And Whereas, a Withdrawal order no. WRC/APW006410/323544(Addl.)/Guj./ $286^{th}/2017/194102-109$ dt. **22.01.2018** was issued to the institution.
- 6. The institution is filed an S.C.A. 10718/2018 (Concerted from SCA no. 22009/2018) before the Hon'ble High Court of Gujarat at Ahmedabad. The Hon'ble High Court vide order dt. 11.07.2018, and the matter was placed in 295th meeting of WRC, held on 30^{th} 31^{st} July', 2018, and the committee observed as follows: -

"The case file was seen. This is a case of appeal. The Appellate Authority vide order dated 12.07.2018 has remanded the case to WRC for further processing the application.

The WRC examined the file and found that the institute has now submitted a staff profile of 1 Principal and 18 faculty members (excluding librarian) who are approved. However, lecturer at sr. 18 does not have M.Ed. degree and should not be appointed.

Hence, Recognition is restored for two units of B.Ed. course."

- 7. And whereas, the recognition granted to the institution for conducting B.Ed. course has been restored of two years duration with an annual intake of **100 seats (two units of 50 students)** vide order no. WRC/APW06410/323544/ (Addl.)/B.Ed./295th/GUJ/2018/199652-199655 dt 28.08.2018 was issued to the institution.
- 8. And whereas, the matter was placed before the WRC in its 310^{th} Meeting held on **August** 19^{th} 21^{st} 2020 and the committee decided to issue show cause notice dt. 02.09.2019 to the institution.
- 9. And whereas, the replies dt. $\underline{21.10.2019}$, $\underline{07.07.2020}$ & $\underline{15.09.2020}$ submitted by the institution, and the matter was placed before the WRC in its 329^{th} meeting held on 17^{th} to 19^{th} February 2021 and the committee decided as follows: -

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

- 1. The revised recognition order was issued to the institution for conducting B.Ed. programme with an annual intake of 200 seats (four units of 50 students each) on 31.05.201. After the compliance of revised recognition order, the restoration order was issued for 100 seats (two units of 50 students each) on 28.08.2018.
- The Institution vide letter dated 15.09.2020 has requested to grant the remaining 100 seats to the institution

In view of above, the Committee decided as under:

The WRC is not empowered to reconsider the matter after elapsing 2.5 years. The institution may file an appeal before the Appellate Authority of the NCTE. Request of the institution is rejected."

- 10. And Whereas, a Conveying letter no. WRC/APW01132/323197 & APW06410/323544/329th/B.Ed./Guj./2021/214747-214750 dt. **27.02.2021** was issued to the institution.
- 11. And whereas, the institution is filed an W.P.(C) 13586/2020 before the Hon'ble High Court of Gujarat at Ahmedabad. The Hon'ble High Court vide order dt. 19.02.2021. The mater was placed before the WRC in its 333rd Meeting held on March 02nd 2021 and the committee decided as follows:

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. The institution has submitted all required documents which were considered by the Committee and found fit the case for restoration of recognition to B.Ed. programme with an annual intake of 200 (4 units) to the institution.

In view of above, the Committee decided as under:

Hence, recognition of the institution be restored for B.Ed. course with an annual intake of 200 students (Four Units) from the date of issue of the order."

- 12. Now Therefore, the recognition granted to the institution for conducting B.Ed. course has been restored as per decision of the WRC in its 333rd meeting and institution is permitted to continue the existing B.Ed. course of two years duration with an annual intake of 200 students (Four Units) from the date of issue of this order.
- 13. The institution shall continuously adhere the NCTE Regulations, 2014 as amended time to

time and any deviation from it shall be liable for action, against the institution, as stipulated under NCTE Act, Rules and NCTE Regulations.
