Whereas, recognition was granted to **THE PRESTON COLLEGE**, **ALKAPURI**, **NEAR NEW HIGH COURT**, **MORAR**, **GWALIOR**, **M.P.** under section 15 (3)(a) of NCTE Act, 1993 for conducting **M.ED. Course** with an annual intake of **40** students vide WRC order **No.WRC/5-6/102/2008/30845-30850 dated 19/3/2008**.

And whereas, the institution has filed W.P. No. 3117/2010 in the High Court of M.P. bench at Gwalior . The Hon'ble High Court Pass order dated 8/7/2010 with direction the Petitioner College is free to raise all the objection before the authority in reply to the show cause notice and the petitioner College is also free to request to authority to conduct another inspection. We hope, the authority shall consider the objections and request of the Petitioner College objectively by passing a reasoned order in accordance with law.

And whereas, the inspection of the said institution was conducted on 21/10/2010. The original file and other relevant documents, visiting team report were placed in 142nd meeting of WRC held on 22nd to 24th, November, 2010 and committee decided to show cause notice be sought from the institution to submit certified copy of following documents by competent authority:

CLU (land use certificate) not submitted.

And whereas, show cause notice issued on 17/12/2010. The institution has submitted reply dated 6/01/2011. The original file and other relevant documents, reply of the institution, visiting team report were placed in 145th meeting of WRC held on 17th to 18th February 2011 and committee decided that permitted to shift in new premises.

Now therefore, Now therefore, in exercise of the power vested under clause 8(11) of NCTE regulations 2009, the WRC hereby permitted to change the premises from THE PRESTON COLLEGE, SURVEY NO.
