### RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to NOBLE COLLEGE OF EDUCATION, RUN BY-DIVYA JYOTI SHIKSHA SAMITI, KHASRA NO. 192/194/195/1, VILLAGE-RAJAKHEDI, SAGAR, MADHYA PRADESH under section 14 (3)A of NCTE Act, 1993 for conducting M.Ed. course (25 Intake) vide order No. WRC/5-6/106/2008/40555-40557 dated 29.08.2008.

- 2. AND WHEREAS, Revised Recognition order was issued to NOBLE COLLEGE OF EDUCATION, RUN BY-DIVYA JYOTI SHIKSHA SAMITI, KHASRA NO. 192/194/195/1, VILLAGE-RAJAKHEDI, SAGAR, MADHYA PRADESH, vide order No. F.No. WRC/APW06323/225108/M.P./2015/8746-8753 dated 18.05.2015 for M.Ed. of Two Years Duration with an annual intake of 50 students for one basic unit of (50 students) from the academic session 2015-2016.
- 3. AND WHEREAS, Compliance was not submitted as per regulations 2014.
- 4. AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- 5. AND WHEREAS, a Show Cause notice was issued to the institution on 06.01.2017 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order:
- 6. AND WHEREAS, the reply of show cause notice was submitted by the institution on 17.01.2017.
- 7. AND WHEREAS, the matter was placed in 297th Meeting held on September 13-14, 2018 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -
  - "...The case file was seen. Consequent to the issue of Revised Recognition order, the institution vide letter dated 27.05.2015 has submitted a list of 23 faculty members which is not approved by the affiliating body. The institution should submit the staff list approved by the Registrar separately for B.Ed. and M.Ed. course as per Appendices-IV & V of NCTE Regulations, 2014. All the faculty members for the M.Ed. course should PH.D/NET qualification. The institution has not submitted FDRs for Rs.12.00 lakhs.

Hence, Show Cause Notice be issued to the institution. Reply should be submitted within one month, failing which recognition will be withdrawn."

- 8. AND WHEREAS, the letter was issued to the institution on 24.09.2018 as per decision of WRC, and its reply received from the institution on 22.10.2018.
- 9. AND WHEREAS, the matter was placed in 303rd Meeting held on February 26-28, 2018 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

    - The Show Cause Notice was issued to the institution on 24/09/2018.
    - The institution has submitted reply of Show Cause Notice on 22/10/2018. On perusal of the reply the institution has not submitted following documents:
    - The institution has not submitted any proof of additional built up area.
    - The institution has not submitted any proof of additional infrastructure.
    - The institution has not submitted any proof of additional fund.
    - The institution has not submitted letter granting approval for the appointment of faculty by Affiliating University.

The institution has not submitted land documents certified by the competent authority.

The institution has not submitted Land Use Certificate issued by Competent Authority.

The institution has not submitted NEC issued by Competent authority.

• The institution has not submitted building plan approved by the competent authority mentioning name of institution, course, khasra No/ Plot No,, total land area, total built up area and earmarked area for each course being run in the same premises.

The institution has not submitted Building Completion Certificate issued by competent

authority.

Hence, the committee decided to withdraw the recognition for M.Ed. programme from the academic session 2019-2020. under Section 17(1) of the NCTE Act, 1993."

- 10. AND WHEREAS, the Withdrawal order was issued to the institution on 15.03.2019.
- 11. AND WHEREAS, the institution has approached Hon'ble High Court of Delhi At New Delhi in W.P. (C) No. 5994/2019 & CM APPL.25901/2019. The order dt. 27.05.2019. the passed by the Hon'ble High Court.
- 12. **AND WHEREAS**, the institution has filed an Appeal to NCTE Hqrs against withdrawal order dt. 15.03.2019. The Appellate Authority passed an order dt. 05.07.2019 remand back the case. And its reply received in WRC on 17.07.2019.
- 13. **AND WHEREAS,** the matter was placed in 309<sup>th</sup> Meeting held on July 23-26, 2019 of WRC and the Committee decided that,

"...The appellate authority remanded back the case to WRC vide order dated 05/07/2019.

The committee considered the observations of appellate authority and the reply submitted by the institution vide letter dated 17/07/2019 and the committee observed that:

- The institution is having B.Ed. and M.Ed. courses with different name viz. Noble College of Education (B.Ed.) and Noble College (M.Ed.).
- The institution is required to initiate the process for changing the name as Noble College of Education.

Hence, show cause notice under clause 17(1) of NCTE Act, 1993 be issued to the institution to submit the above within 30 days from the date of issue of show cause notice."

- 14. AND WHEREAS, the Show Cause Notice was issued to the institution on 08.08.2019 as per decision of WRC, and its reply received from the institution on 09.08.2019.
- 15. **AND WHEREAS,** the institution had approached Hon'ble High Court of Delhi At New Delhi in W.P. (C) No. 8407/2021 . the order dt. 13.08.2021 passed by the Hon'ble High Court.
- 16. **AND WHEREAS,** the matter was placed in 346<sup>th</sup> Meeting held on 25-27 November, 2021 of WRC and the Committee decided that:

"...The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

This is a RPRO case and same was remanded back by the Appellate Authority.

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the institution for M.Ed. course with an annual intake of 50 students (One unit) be restored.

The institution has also submitted an application for change of name from Noble College to Noble College of Education and submitted requisite fees.

In view of the above the Committee decided to allow the change of name of the institution from Noble College to Noble College of Education."
