RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to **SWAMINARAYAN B.ED. COLLEGE, C/O SWAMINARAYAN GURUKUL GADHADA ROAD, BOTAD, BHAVNAGAR-364710, GUJARAT** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/5-6/92/2006/11589 dated 02.03.2007.

AND WHEREAS, Revised Recognition order was issued to **SWAMINARAYAN B.ED. COLLEGE, C/O SWAMINARAYAN GURUKUL GADHADA ROAD, BOTAD, BHAVNAGAR-364710, GUJARAT** vide order No. F.No WRC/APW02583/323299/B.ED.(REVISED ORDER)/2015/ 145508-145542 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic unit of 50 students each from the academic session 2015-2016.

AND WHEREAS, Compliance was not submitted as per regulations 2014.

AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

AND WHEREAS, a Show Cause notice was issued to the institution on 08.08.2016 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.

AND WHEREAS, the reply of show cause notice was not submitted by the institution.

AND WHEREAS, the matter was placed in 277th Meeting held on June 29-30, 2017 of WRC and the Committee decided that. "The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The case file was seen. In response to the WRC letter dt. 08/08/2016, regarding fulfillment of requirements for 2 units of the B.Ed. course, the institution has represented that it had requested only for 1 unit (50 students). Keeping this in mind the WRC looked at the staff profile and found that the institution had submitted a list of 7 faculty members excluding Librarian. Out of these, the faculty member at serial nos. 5,6 and 7 do not have a PG degree.

The institution needs to appoint a qualified Principal and 3 faculty members out of which 1 should be from Physical Education and another from Performing Arts or Fine Arts. The third can be Methodology/Foundation course. The institution should submit the full list of faculty duly approved by the affiliating body for considering the continuation of Recognition for 1 unit of B.Ed. from the session 2017-2018.

As per NCTE Regulations, 2014, FDRs for 12 lakhs in joint operation with the RD, WRC is required. The institution should also full fill this condition.

Show Cause Notice be issued on the above grounds and reply should be received within 1 month."

AND WHEREAS, a Show Cause Notice was issued to the institution on 05.07.2017 and its reply received on 11.07.2017.

AND WHEREAS, the matter was placed in 282th Meeting held on October 24-26, 2017 of WRC and the Committee decided that. "The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The case file was seen. Show Cause Notice dated 05.07.2017 was issued to the institution regarding appointment of qualified Principal and three faculty members. The institution has not complied till date.

Hence, Recognition is withdrawn from the session 2018-2019."

AND WHEREAS, a withdrawal order was issued to the institution on 02.11.2017.

AND WHEREAS, the institution has filed an Appeal to NCTE Hqrs against withdrawal order dt. 02.11.2017. The Appellate Authority passed an order dt. 12.09.2018 remands back the order appealed against and its reply received in WRC on 20.09.2018.

AND WHEREAS, the matter was placed in 299TH Meeting held on October 30 & November 01, 2018 of WRC and the Committee decided that.

"... This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC for revisiting the matter after the appellant institution submits required documents and taking further action expeditiously.

On perusal of the reply dated 19.09.2018, the Committee observed that:-

- 1. The institution has submitted the approved staff list of 1+3 faculty members. Whereas, the institution has to submit complete list (1+7) required for one unit approved by the affiliating body as per Withdrawal Order No.WRC/APW02583/323299/ Guj./282nd/2017/192483 dated 02.11.2017.*
- 2. Building Completion Certificate duly signed by competent authority submitted.*
- 3. FDR for Rs.12.00 lakhs as required under clause 10(1) of NCTE Regulations, 2014 submitted.*

Hence, the Committee decided that Show Cause Notice be issued to the institution. Reply should be submitted within one month, failing which recognition will be withdrawn u/s 17(1) of the NCTE Act, 1993."

AND WHEREAS, a Show Cause Notice was issued to the institution on 19.11.2018 and its reply received on 08.05.2019.

AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 1008/2020 dt. 27.01.2020.

AND WHEREAS, the matter was placed in 313th Meeting held on February 25-27, 2020 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The Committee considered the matter keeping in view the directions of the Hon'ble Court in W.P. (C) No. 1008/2020 and institution's reply dated 14/12/2018 & 08/05/2019 and observed as under:-

- 1. The Principal I/c (Shri MeghaniAshvinbhai Ramesh Bhai) is not having eight years experience of teaching in Secondary Teaching Education Institution. The subject of P.hD. is not mentioned. He does not have adequate percentage of marks in PG as per NCTE Norms.*
- 2. The faculty at Sl. No. 2 (Ms. SheetalbenJagdishchandraSoni), Sl. No. 3 Mr. Paraleeya Bharat Bhai Dhudabhai does not have adequate percentage of marks in PG as per NCTE Norms.*
- 3. Staff for Performing Arts, Fine Arts and Health and Physical Education are not appointed.*

In view of above, the committee decided that the withdrawal order 02.11.2017 issued by WRO stands."

AND WHEREAS, a withdrawal order was issued to the institution on 04.03.2020.

AND WHEREAS, the institution has filed an Appeal to NCTE Hqrs against withdrawal order dt. 04.03.2020. The Appellate Authority passed an order dt. 15.09.2020 confirm the order appealed against.

AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 7662/2020 with CM APPL. 25353/2020 dt. 15.04.2021.

AND WHEREAS, the institution has filed an Appeal to NCTE Hqrs against withdrawal order dt. 04.03.2020. The Appellate Authority passed an order dt. 10.09.2021 remands back the case.

AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 11511/2021 dt. 07.10.2021 the operative part is produced here below:-

"...In the event the WRC is unable to dispose of the matter within the aforesaid period for any reason, it is directed to issue an order of restoration of recognition to the petitioner to enable it to participate in counselling, and admit students for the academic year 2021-22. The order will have effect until and unless and a fresh order of withdrawal is passed by the WRC against the petitioner.

NOW THEREFORE, recognition of the institution viz **SWAMINARAYAN B.ED. COLLEGE, C/O SWAMINARAYAN GURUKUL GADHADA ROAD, BOTAD, BHAVNAGAR-364710, GUJARAT** for B.Ed. course with an annual intake of 100 students (Two units) is hereby restored.

The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dt. 31.05.2015.
