CONTINUATION ORDER

WHEREAS, WRC-NCTE had granted permission to the institution namely TALAT SHIKSHAN MANDAL, NANDRABAD, TQ. KHULTABAD, AURANGABAD, MAHARASHTRA vide order No. WRC/5-6/99th/2007/C-25887-25894 DATED: 09.01.2008 for conducting B.Ed. (M) (CO-ED.) course with an annual intake of 100 students.

2. AND WHEREAS, the Revised Recognition order was issued to the institution vide dated 31.05.2015 for B.Ed. course with an annual intake of 100 students with a direction to submit the compliance to the Revised Recognition order on or before 31.10.2015.

3. As no compliance to the revised recognition order was received, the matter was considered by WRC in its 255th meeting and as per the decision of WRC, Show Cause Notice for non-submission of compliance was issued vide dated: 17.03.2017.

4. The institution has not submitted any reply to the Show Cause Notice dated 17.03.2017. The matter was considered by WRC in its 311th meeting, wherein the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.

Accordingly, withdrawal order was issued to the institution on 14.10.2019.

5. AND WHEREAS, the institution filed, Writ Petition No. 12323/2019 In the High Court of Judicature at Bombay Bench at Aurangabad against the withdrawal order dt. 14.10.2019. the Hon'ble high court of Bombay passed an order dt. 14.01.2020.

6. AND WHEREAS, the matter was considered by the WRC in its 313th meeting held on 25th - 27th February 2020 and the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act.

Accordingly, Final Show Cause Notice was issued to the Institution on 05.03.2020.

7. AND WHEREAS, the institution filed, Writ Petition No. 8496/2020. In the High Court of Judicature at Bombay Bench at Aurangabad and the Hon'ble high court of Bombay passed an order dt. 22.12.2020.

8. AND WHEREAS, the matter was considered by the WRC in its 329th meeting held on 17th - 19th February 2021 and the Committee decided as under: -


As per direction of the Hon'ble High Court, Bombay Bench at Aurangabad vide order dated 22.12.2020, the original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. The institution has submitted all required documents which were considered by the Committee and found fit the case for continuation of Recognition of the institution.

In view of above, the Committee decided as under:

Recognition of the institution be continued for B.Ed. programme with an annual intake of 100 (two units).

9. **NOW THEREFORE, the recognition granted to the institution for conducting B.Ed. (M) (CO-ED.) course has been continued with an annual intake of 100 students (two basic units of 50 students each) as per decision of the WRC in its 329th meeting.**
10. The institution shall continuously adhere the NCTE Regulations, 2014 as amended time to time and any deviation from it shall be liable for action, against the institution, as stipulated under NCTE Act, Rules and NCTE Regulations.
