**WITHDRAWAL ORDER**

Whereas, the WRC had granted the recognition to St. Thomas College, (Run by St. Thomas Mission) Ruabandha, Bhilai, District - Durg, Chhattisgarh-490006 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2002-2003 vide order No. WRC/5-6/40/2002/05720-24 dt. 20.09.2002.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the St. Thomas College, Bhilai, Durg, Chhattisgarh offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 22.01.2015 from the institution, a revised recognition order no. WRC/223076/B.Ed. (Revised Order)/2015/144368 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students each) from the session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014:-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255<sup>th</sup> meeting held on June 22-24, 2016 and Committee decided to issue Show Cause Notice dt. 16.08.2016.

And whereas, reply dt. 02.09.2016 was submitted by the institution was placed before the WRC in its 290<sup>th</sup> meeting held on March 21<sup>st</sup> - 23<sup>rd</sup>, 2018 and the Committee decided as follows :-

*"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice was issued on 16.08.2016. The institution replied on 02.09.2016.*

*The institution has submitted a list of 8 faculty members which is not approved by the Registrar. Principal has not been appointed.*

*The Building Completion Certificate in the prescribed format and counter signed by a Govt. Engineer not submitted in original and FDRs for Rs.12.00 lakhs not submitted (in joint name) in original.*

*Hence, Recognition is withdrawn from the end of the next academic session."*

Now, therefore, the recognition of St. Thomas College, (Run by St. Thomas Mission), Ruabandha, Bhilai, District - Durg, Chhattisgarh-490006 for conducting B.Ed. programme of two years duration with an annual intake of 100 seats (two basic units of 50 students), is **hereby withdrawn from the academic session 2018-2019** in terms of Section 17(1) of the NCTE Act, 1993.
