With reference to the above, it is to inform that as per NCTE Regulations, 2014 a revised recognition order no. WRC/223076/B.Ed. (Revised Order)/2015/144368 dt. 31.05.2015 was issued to the institution for conducting B.Ed. course of two year duration with an annual intake of 100 students (two basic units of 50 students each) from the session 2015-2016.

The WRC in its 292^{nd} meeting held on May $15^{th} - 17^{th}$, 2018 considered the reply dt. 04.04.2018, 18.04.2018 & 05.05.2018 submitted by the institution, for compliance of conditions as mentioned in the revised recognition order dt. 31.05.2015 and decided as follows:-

"The case file was seen. Consequent to the issue of the Show Cause Notice, the institution has submitted a staff profile of 1 HOD and 15 faculty members, who are qualified and approved by the competent authority.

Hence, permitted to continue."

Therefore, the <u>revised recognition order no.</u> WRC/223076/B.Ed. (Revised Order)/2015/144368 dt. 31.05.2015 issued by the WRC for conducting B.Ed. curse of two year duration with an annual intake of <u>100</u> students (two basic units of 50 students each) will remain continue.
